C - PRESENTATIONS

1. <u>Aboriginal Education – Mr. Doug Hoey, Principal</u>

The Superintendent of Schools introduced Mr. Doug Hoey, Principal of Aboriginal Education. Mr. Hoey introduced Ms. Annette McComb, Senior Support Worker.

Mr. Hoey made a presentation to the Board which outlined recent changes in the Aboriginal Department and initiatives which have been implemented recently. He said the main aim of the department is to focus on improving literacy, numeracy, grade rates and retention rates. Ms. Annette McComb said that she was thrilled to be working in the department and explain her new role, and her work with the Keeping Kids in School team, which has been very successful. Mr. Hoey outlined other initiatives which include increased student mentoring, more cultural presentations, a shift to a family of schools approach, and increased communications.

Mr. Hoey and Ms. McComb were thanked for their informative presentation and they left the meeting.

• <u>Clarification on Media Comments</u>

Chair Ashlie clarified that trustees do not have access to employee files as reported in a recent local media article.

With respect to the local media article on the disqualification of Mrs. Joostema, Chair Ashlie said that she has asked for a copy of the court transcripts to verify that the judge had not "alluded that "there might have been political motivations to the Board's decision to seek to have Joostema removed", as reported in the local media, by Trustee Vdovine.

Trustee Marshall asked Trustee Vdovine to explain his comments "this isn't the first time the Board has taken legal action to muzzle opposition".

Trustee Vdovine said that there was legal involvement regarding a disagreement with the DPAC Chair and the resulting apology the Board had to make to the DPAC Chair, which he said was embarrassing. He said he stood by his comments.

Trustee Marshall stated that the action was taken not to "muzzle opposition", but rather to protect an employee.

Trustee Vdovine said that if there was a concern about comments reported out to the media, he would like to find out exactly what was meant by Trustee Rempel's comments that "justice has been done", he said he thought the comments were also inappropriate.

Chair Ashlie stated that the judge has given his ruling with respect to Mrs. Joostema and that it is time to move forward. She said Trustee Vdovine's comments indicate this is not happening. She said it was important to move on with Board business and that there be no further discussion on the matter. The required motion is merely a formality.

Trustee Vdovine said that he did not feel that this was a formality. The Secretary Treasurer stated that legal advice, following the Supreme Court ruling was that the Board should, by motion, accept the disqualification.

Trustee Vdovine said that he disagreed with the position advocated by legal counsel but still contended that it was both politically motivated and grandstanding.

Trustee Butler asked whether it would be possible to get a copy of the legal advice.

The Secretary Treasurer stated that the legal advice was verbal. However, he could arrange for a copy to be made available.

By-election Discussions

Vice Chair Ward asked for clarification on the timeline for Mrs. Joostema to appeal the court's decision, the Board's timeline to call a by-election, and the cost of such a by-election.

The Secretary Treasurer stated that Mrs. Joostema has 30 days to appeal the courts decision, the Board would have 30 days to call a by-election, and that the cost would be in the order of \$12,500.

The Vice Chair said she believed that, had the decision to disqualify Mrs. Joostema occurred prior to the end of December, the Board, according to the School Act, would be required to conduct a by-election. However, if the decision occurred after January 1st, it would be the Board's decision to call for a by-election.

The Secretary Treasurer confirmed the Vice Chair's understanding of the process.

Trustee Rempel said that he did not believe it was financially responsible for the Board to hold a by-election at this time of year, and pending Municipal elections in November.

J - QUESTION PERIOD

1. Trustee Questions

Trustee Vdovine asked if there was a way to determine how many students ride public buses to school. Assistant Superintendent Unwin stated that this information would have to be gathered through a survey, but it could be done if required. Trustee Vdovine explained that a bus pass is offered at UBC at a discounted rate based on the bus usage in certain areas. Chair Ashlie said that this could be considered for the future.

2. Public Questions

Ms. Psota stated that, Kelowna school district had dropped the "coordinated timetable", and if the District intended to base the model on Kelowna, it might be a good idea to find out why it had been dropped.

Assistant Superintendent Jan Unwin said that she was not aware that Kelowna had a coordinated timetable in place. She said that should SD42 find that the coordinated timetable was not working in SD42, it would be dropped.

Ms. Gladys Hewson asked that if a trustee votes to abstain does that mean that the vote is a yes, or a no?

Mrs. Hewson was advised that the abstaining vote would be recorded as a "yes" vote if the majority of votes were in the affirmative.

Mr. Hill asked whether the Board was familiar with the phrase "Libel Chill". The Board said it was not.

Mrs. Wagner asked the Board to provide clarification on its comments that the legal letters sent to former DPAC Chair Deb Appleby, were sent to "protect an employee".

She said that she did not believe this to be the case, she had all of the legal documents and could provide copies if the Board did not have them.

Chair Ashlie said that Mrs. Wagner was not correct. A letter was sent in regards to the submission to the External Review Team to all PAC Chairs.

Mrs. Wagner asked whether the Board Chair was publicly stating that all the actions taken against Mrs. Appleby, were to "protect an employee".

Chair Ashlie advised Mrs. Wagner that two letters were sent to Mrs. Appleby. One to protect an employees' reputation, the other regarding an accusation made by the DPAC Chair in regards to the Board Chair.

Mrs. Wagner asked for a copy of all of the documents the Board had on the matter. The Board Chair said that Mrs. Wagner had all of the documents and there would be no further discussion on the matter.

Mrs. Hewson asked whether enrolment was increasing or decreasing. Assistant Superintendent Randy Cranston said that the kindergarten numbers are down 22 students from last year. Projections show that the elementary enrolments will be down by 363 students next year.
