C – PRESENTATIONS

1. <u>Thomas Haney Secondary Orchestra</u>

The Superintendent welcomed Mr. Dumas, music teacher, who introduced nine of his Junior Orchestra members from Thomas Haney Secondary School.

The students performed two pieces of music for strings. Mr. Dumas said the program has been in place since September, and is the first of its kind in Maple Ridge-Pitt Meadows.

The Board Chair thanked Mr. Dumas, and the students for the excellent musical recitals, and they left the meeting.

2. <u>2010 Legacy Group – Ms. Bonnie Telep and students</u>

The Board welcomed Ms. Telep and students to the meeting.

Ms. Telep thanked the Board for providing the opportunity for the group to speak to the Board about the Spirit of BC Community Committee. She outlined the Committee's work since its inception in 2003, and its goal to help residents and businesses contribute to the success of the 2010 Winter Olympic Games. She said that Maple Ridge-Pitt Meadows is one of 92 Community Committees chosen by the 2010 Legacy Group.

Three District students, who belong to the Altitude Youth Group, described the activities they had organized and the leadership skills they had developed during their involvement with the 2010 Legacy Group.

The Board Chair thanked Ms. Telep and the students for the work they have done on behalf of the communities of Maple Ridge and Pitt Meadows.

Ms. Georgi, a parent, was asked to address the Board on the French Immersion Program.

Ms. Georgi referred to recommendation #4 presented in the Board report on French Immersion which indicates the declining numbers in the late French Immersion program at Highland Park, that there is space at the late French Immersion program at Fairview, and that the District will no longer offer Grade 5 late French Immersion at Highland Park effective September 2009.

Ms. Georgi advised that Pitt Meadows has given approval for 338 housing units at Lougheed and 190th Avenue, some of which are multi-family, as well, the proposed development on McMyn Road in the 190th Avenue area, which are in the Highland Park catchment area.

She said she felt the enrolment numbers could be more than originally projected and questioned why the FI program should be moved to Fairview when potential growth is projected for Pitt Meadows. She asked the Board to consider leaving the late French Immersion program at Highland Park because of the anticipated growth.

He said that Dr. Oborne, in his presentation to the Board on April 30th had advised that research would indicate that French Immersion programs below 100 are not considered to be educationally sound.

Superintendent John Simpson said that he is confident that once Ms. Rowen and Dr. Cranston have spoken with the parents at Riverside, they will realize that it is just not a feasible option, nor a good learning environment for their children.

Mr. Todd Hill, a parent and DPAC representative asked what the enrolment cut off number would be to make the FI program at Riverside viable. Dr. Cranston said that there is no enrolment cut off number set; the concern would be the viability and quality of the program.

Mr. Steve Dillan said that he had already sent an e-mail to the Board expressing his concern with respect to the declining enrolment in the FI program at Riverside, the possible closure of the school in the future, and his perspective generally as a parent. He asked Riverside students will be factored or recognized to attend Laity View or what plans are in place to encourage more students to enroll at Maple Ridge Elementary.

The Superintendent advised that the Laity View FI program is at capacity, and it would be challenging to add more students.

The Board Chair said that she expected Mr. Dillan to become involved in the broader discussion on the FI programs, and suggested he present any further questions he may have at upcoming meetings with staff.

Ms. Cathy Barrington, an employee at Riverside school, said that if the FI Program is withdrawn from the school, the English student enrolment would only be in the 100's, which may not be considered sufficient to keep the school open. She asked when these discussions would take place.

Chair Ashlie stated that the Board is not considering closing schools at this time. It will determine where the FI programs are to be established and then will have discussions on closure, if necessary.

Ms. Barrington suggested that the establishment of a day care at the school might increase enrolment. Assistant Superintendent Randy Cranston advised that the school has been identified as a facility to house day care services.
