## Dear Sirs/Mesdames:

Thank you for receiving my presentation of February 23, 2011, regarding health risks of non-thermal biological effects from long term low level microwave radiofrequency radiation as emitted by the Wi-Fi Base Stations now installed in Maple Ridge schools.

As a parent, I do not relinquish my legal right and moral obligation to choose the risks my children will sustain. Further, the school does not have a right to make such choices on my behalf.

I have chosen to educate myself extensively on the issue of adverse health effects and no amount of statements assuring safety, nor reliance on platitudes from Health Canada, can evaporate the actual peer reviewed and published science showing risks to life from this toxic exposure. My daughter has suffered greatly as a result of close and continuous exposure to a Wi-Fi Base Station in Laity View Elementary over a period of two years. I was not asked for my consent, nor are any parents asked for their consent. Therefore, this school district has no waiver of liability from me, or other parents for the continued irradiation of our children from Wi-Fi Base Stations. This is a serious oversight given continuously emerging science evidencing health risks from non-thermal biological effects.

It is unconscionable for the school district, its trustees, administrators, teachers and staff to work for anything other than the best interests of all our children. There is no health risk from wired technology, while

there is clear evidence of health risk from wireless microwave radiation used in telecommunications

On behalf of my daughter, whose health has been severely damaged by exposure to Wi-Fi Base Stations in Laity View Elementary, I request Maple Ridge School District institute a process of Informed Consent whereby parents are the ones to choose the level of risk their child will sustain. Again, it is not the school's legal right to supersede parental authority with regards to exposure of children to microwave radiation on a daily basis while in school.

I request that you oblige me with a formal written response to my presentation and this letter and the requests made therein. I also request that you create a committee consisting of parents with no ties to the telecommunications industry and no ties to the school board to examine the issue, including the latest research and the steps that other international governments are taking to safeguard the children in their schools.

Here is a suggestion for a consent form that would move the liability away from the school district, and back to the parent, where it belongs:

# Consent for Exposure to Microwave Radiation from Wireless Technology

I am satisfied that I have been informed of my right to obtain as much information about the health effects of exposure to low level, non-ionizing microwave radiation as I feel necessary, including information beyond that information provided to me by the school or School District 42 to the extent that I require and am not, in any way, relying solely upon information provided by School District 42 respecting the nature and extent of the risks and hazards associated with my child's exposure to low level, non-ionizing microwave radiation from wireless technology in School District 42 school buildings.

I freely and voluntarily assume the health risks and hazards inherent in the nature of low level, non-ionizing microwave radiation and understand and acknowledge to the school and School District 42, that my child, as a participant, may suffer personal and potentially serious injury to health. I acknowledge that it is my responsibility to advise the school of any medical or health concerns of my child that may affect his/her risk level when being exposed to non-ionizing microwave radiation from wireless technology used at school.

Based on my understanding, acknowledgment and consents as described herein, I agree that my child has my permission to be exposed to the non-ionizing microwave radiation from wireless technology at school.

Re: Significant Oversight(Error or Omission) Reported in Safety Code 6 (2009)

## Dear Minister Aglukkaq;

There was an oversight(unintentional error or omission) reported in safety standards associated with Radio Frequency Emfs interaction with humans. The oversight in safety standards was reported to Health Canada in September, 2010 and by expert witness to Canadian Parliament's Standing Committee on Health in October 2010. The recommendations of the committee in December 2010 included Health Canada thoroughly investigating the error or omission reported in safety standards. That error is the causation Health Canada is looking for in whether emf interaction with tissue is happening. The error or omission qualifies electromagnetic induction, radiation, etc is going to happen.

Due to the error in safety standards, the reporting Health Canada would normally get has changed because it is missing critical data. Professional reporting to date including the BC Centre of Disease Control and recent reporting for Simcoe School District on Wi Fi Safety have missed critical data when all of their data refers to heating of the appliance but totally neglects to mention human vulnerability to emfs, electromagnetic induction, high speed radiation or mention the natural frequencies of the biologic systems. It is impossible to solve a frequency equation when you leave out frequencies of the biologic systems. We generate electricity by waving a conductor through a magnetic field or moving the field around the conductor. In Schools, the Wi Fi 2.4 or 5 Ghz frequency is the moving magnetic field and EACH person's biologic systems are the electrical conductors.

Further complicating the adverse health effects is that each child already has their own electrical systems that are vulnerable to electrical change with emfs induced. (If you changed your voltage on your computer, it wouldn't work). Health Canada calls it nerve and muscle depolarization or a heat effect which is the reason it is to be avoided. Any tissue or biologic systems interacting with the emfs will polarize at twice the frequency (4.8 to 10 Billion Times Per Second). This isn't discussing what the computer is doing. Any present day reporting from Health Canada on emfs has to incorporate the electrical considerations without exception or it will be allowed science which affects health, medical costs, administration, sustainability, leganty and liability.

As an example of the errors in the reporting on the dangers of emfs, there is a report attached from the BC Centre of Disease Control. The Head of Radiation Protection Services wrote a report on Wi Fi Safety and his reporting neglected to incorporate critical electrical information on electromagnetic induction. His reporting didn't incorporate the electrical profession into an electrical problem and he isn't qualified which impacts the reporting. As a result of the flawed reporting the school district is told Wi Fi is safe where the reality is Wi Fi is to be avoided. The children, teachers, etc are being electromagnetically induced and Health Canada's Safety Code 6 states the unintentional stimulation of tissue is to be avoided because experimental studies show it can lead to nerve and muscle depolarization or heat effect.

It has been 3 months since it was recommended that Health Canada investigate the significant oversight reported in safety standards. All it would take is a call to electrical standards to qualify induction happens and it is the way we create electricity. Health Canada and Industry Canada are presently reporting Wi Fi is safe in schools but not declaring the error or omission was reported showing it isn't safe in schools. That is an administrative decision at the cost of student and teacher health.

It requires a response as to why provinces haven't been informed there is an error or omission in safety standards reported? How are the school districts supposed to administer their areas with missing information? The laws have changed with the error reported and Wi Fi or any influence by emfs is to be avoided.

There is a reason the electrical and construction industry do their jobs with those associated costs. It keeps people and the data safe. Schools need to be wired without exception or any emf can impact people.

Electromagnetically inducing populations is dangerous and if it were done in a military application the planes would be in the air. This somehow escaped us as not causing the unintentional stimulation of tissue or a mysterious heat effect.

Our reporting to you as the authority has been because we are government trained and certified professionals that consult at operations levels. We lecture emf interaction in medical education for education credits required for licensing in Canada and the U.S.

Can you please forward the work completed to date on the reported error in safety standards and when you will report the error to provinces? Has the Defence Minister been informed of an error in safety standards reported? Did the Health Minister report the error to the United States or WHO?

This issue requires immediate attention as is a national emergency and we look forward to answering questions within our professional capacity.

Curtis Bennett, introduced himself as an expert witness serving the Canadian parliamentary hearings finding errors (or omissions) qualifying electromagnetically induced damage to humans.

- This year's award-winning students were motivated and inspired by Jude Platzer of the Josh Platzer Society for Teen Suicide Prevention. The students provided a compelling presentation on the social matters surrounding suicide including a poster and overhead presentation.

Superintendent Unwin thanked senior staff for attending tonight's meeting and noted the calendar originally distributed prior to the meeting has some changes. New handouts were provided. The changes are reflective upon the wish to honour a two (2) year commitment with respect to Common Professional Development days with the MRTA.

As part of the Learning for Tomorrow Forum, continued financial pressures and in order to bring options to the Board seeking creative ways to save money, build efficiencies and fairness across the District, an independent consultant, Horizon Research & Evaluation Inc. was engaged to assist with the evaluation process. Research conducted indicates the proposed changes would not have an adverse effect on student learning and would alternatively provide other opportunities.

The Superintendent presented a powerpoint summarizing the consultant's process. The Board is asked tonight, to approve a public feedback component for 30 days in accordance with the *School Act* prior to making a final decision.

Additional supportive comments provided if approved:

- The District would work with community groups;
- A transition team could be provided if the need is there;
- Meet with community groups to see what the District can offer;
- Public information night is scheduled for March 29, 2011 at Thomas Haney Secondary School;
- Will continue discussions with CUPE regarding particular groups who are not tied to students;
- Continue discussion with MRTA to discuss local school calendars;
- Work with Kanaka Creek Elementary regarding inclusion;
- · Benefits of teacher collaboration time;
- Possible introduction of new subjects to students;
- Grade 7 elementary schools collaborating with secondary catchment schools;
- Health and wellness benefits;
- Greater efficiencies in balancing schedules for better time-share opportunities for staff;
- Zero impact on excluded staff;
- First step is to seek parental feedback.

Suggestions were made to review this over a two (2) or three (3) year program as one(1) year is too short of a timeline to measure.

The consultant has completed her work and it is up to the School District to determine which plans work best for everyone. Support for the consultant was provided in the added benefit of her questioning 'why we do the things we do' compelling the District to review past practices.
