

# **Board Meeting Highlights September 20, 2023**

Board Chairperson Yamamoto opened the meeting with a statement affirming the district's dedication to creating an inclusive culture of care and belonging, where the well-being, diversity, and success of all learners is supported and celebrated. Chairperson Yamamoto noted that discrimination, harassment, or any form of hate based on sexual orientation, gender identity, or any other characteristic has no place in our schools or in our communities.

## **Supporting All Learners: Enhancing Student Learning Report**

Superintendent Dhillon, Deputy Superintendent Schwarz and assistant superintendents Bikic, Cober, Scarcella and Vandergugten presented the *Supporting All Learners: Enhancing Student Learning* report to the board. The report consists of three sections – Intellectual Development, Human and Social Development, and Career Development – and provides both currently available data and analysis of this data. ## 2022/23 Audited Financial Statements

#### 2024/25 Minor Capital Plan

The board approved the 2024/25 Minor Capital Plan for submission to the Ministry of Education and Child Care. The projects included in the plan have been determined in accordance with the methodology defined in the school district Strategic Facilities Plan and are categorized under four programs: School Enhancement Program, Carbon Neutral Capital Program, Playground Equipment Program and Food Infrastructure Program. The 2024/25 Minor Capital Plan submissions can be viewed in the September 20, 2023, public agenda package.

# **Board Meeting Schedule Change**

The board approved a change to the Baord of Education regular board meeting schedule for 2023/24, moving April 10 and April 24 meetings to April 17 and May 1, 2024, respectively, to ensure sufficient time for public consultation following the Ministry of Education and Child Care's operating grant announcement.

## **Superintendent's Update**

Superintendent Dhillon updated the board on school start-up, opening with an expression of gratitude to custodial, grounds, and facilities staff for work completed over the summer break, and to all staff for their dedicated and skillful work in preparing district schools and the system as a whole for a safe return of students. Superintendent Dhillon shared photos from schools and also acknowledged the upcoming National Day for Truth and Reconciliation.

# **Summer Learning Update**

Assistant Superintendent Ken Cober provided the board with an update on Summer Learning 2023, which was offered at Katzie Health Centre, Golden Ears Elementary School, and Thomas Haney Secondary School (THSS). At the Katzie Health Centre, the program for elementary-aged students involved activities emphasizing hands-on literacy and numeracy skills, integrating, wherever possible, traditional teachings such as weaving, song and outdoor physical activities. For secondary students, the emphasis was on

leadership, community connections, outdoor physical activities, and cultural enrichment. In the meantime, Golden Ears Elementary hosted 441 students from grades 1-7, while THSS hosted the secondary transitions program for 106 students in grade 7, the summer learning program for 71 students in grades 8-9, and summer learning courses for 512 students in grades 10-12. THSS also provided summer learning opportunity for Train in Trades Program students.

## **Equity Action Plan Implementation Review Report 2022/23**

Principal of Aboriginal Education Kirsten Urdahl-Serr and Vice Principal of Aboriginal Education Kathleen Anderson presented to the board on the *Equity Action Plan Implementation Review* for 2022/23. The report includes an overview of actions implemented, lessons learned, successful practices, and plans for moving forward/next steps. #### **Secretary Treasurer's Update**

Secretary Treasurer Richard Rennie provided an update on facilities projects, noting that the district completed consultation on the seismic replacement of Pitt Meadows Secondary School (PMSS) and the seismic replacement and expansion of Eric Langton Elementary (ELE). Secretary Treasurer Rennie noted that the district is planning to complete its business case for PMSS by October 2023, and that it is on track to begin construction of the seismic replacement and expansion of ELE in January 2024, and to complete construction of the new school facility by December 2026.

The goal of the Board Policy Development Committee is to review all existing board policies within the four years ending 2025/26.
