

Presentation: Student Voice

Vice Principal Lisa Kania presented to the board on Student Voice, highlighting the district's commitment to ensuring that students have meaningful opportunities to share their perspectives and influence decision-making. She provided an update on recent student engagement efforts, including the BIPOC Student Forum, where students shared input on responding to racist incidents, strengthening anti-racism education, and fostering student-led change. She also highlighted student participation in the budget process, where student voice representatives presented to the board on student priorities for the 2025/26 Preliminary Budget. At the close of the presentation, Kania noted that the district continues to explore ways to strengthen student engagement and leadership development through a more structured and inclusive approach.

Strategic Plan Update

The board received a presentation from Superintendent Downs on proposed updates to the district's Strategic Plan and directed staff to engage with the Indigenous Education Community Gathering Table and each partner group on the proposed changes. Feedback from these discussions will be presented to the board at an upcoming public meeting. The district's strategic priorities are designed to support every learner and enhance the effectiveness of the system.

Facility Rental and Licensing Fees for 2025/26

The board approved facilities rental rates and licensing fees for 2025/26. Rental rates for classrooms, multipurpose rooms, libraries, and gyms under the cost recovery model applicable to non-profit organizations (NPOs) are set to rise to recover increased costs, while the rates for private and commercial businesses are set to decrease to align with market rates for such businesses. Rental rates for filming remain unchanged, while the licensed child care rental rate will rise to recover increased costs. The board also approved new rental rates for parking lots and for the Garibaldi Secondary Theatre. Amended Annual Budget and Second Quarter Financial Statements

Secretary Treasurer Rennie presented the 2024/25 Amended Annual Budget and Second Quarter Financial Statements to the board, noting that while the operating budget is balanced overall, a structural deficit of \$0.89 million remains, with ongoing expenses exceeding ongoing revenue. Addressing this shortfall will require either expense reductions, revenue increases, or both to ensure long-term sustainability. The full report and analysis are available for review in the March 5, 2025, agenda package.

Superintendent's Update

In athletics, the Maple Ridge Ramblers won the provincial wrestling championship, while both the senior boys' and senior girls' basketball teams at Pitt Meadows Secondary advanced to the provincial championships. Theatre productions included *A Midsummer Night's Dream* at Thomas Haney Secondary and *The Wizard of Oz* at Westview Secondary.

Superintendent Downs also highlighted various Pink Shirt Day initiatives, including the "You're Not Alone" kindness card project by a Grade 7 Glenwood Elementary student in support of the Salvation Army. Trustee Remuneration for 2025/26

On May 18, 2022, the board approved an annual adjustment of trustee remuneration for the period 2022 to 2026 effective July 1 each year, based on Metro Vancouver Consumer Price Index (CPI) change from the previous year. The board received trustees' remuneration for 2025/26 (which includes a CPI Vancouver 2024 adjustment of 2.6%) for information. Total trustee remuneration for 2025/26 is as follows: trustees \$32,950; vice-chairperson \$34,450; chairperson \$35,950.
