We have two full time support staff in the class to work with the 3 students. I cannot imagine even more students for our amazing Teacher and with possibly less support staff in the classroom. This result will be tragic for all of the students. My son is average who does not require special help but who is still just 6 and needs normal help any Kindergartener needs, but I feel would be completely lost if there were even more students in his class.

BILL 11: EDUCATION STATUTES

AMENDMENT ACT, 2015

Decision

BACKGROUND/RATIONALE:

The motion is needed because Bill 11, Education Statutes Amendment Act, 2015 overrides the authority of democratically elected school boards.

Bill 11 repeals section 79.4 of the School act and adds new provisions which would broaden the scope of the Minister's authority to issue administrative directives to a board or francophone authority (Bill 11, ss.28, 29 32 and 33)

Bill 11 amends the special advisor provision of the School Act to:

- provide the Minister with the ability to appoint special advisors or special advisory committees (Bill 11, s. 25 and s.40)
- add a provision indicating that at the request of the Minister, a report of the special advisor/special advisory committee must include recommendations about student performance and the conduct of the board/francophone education authority in respect of any educational, financial or community matters;
- add a provision indicating that the Minister, by order, may require a board/francophone education authority to implement recommendations set out in the special advisor's report within a time period specified by the Minister.
- broadens the circumstances when the Minister may appoint a special advisor or special advisory committee.
- the amendments assert that Boards of Education are required to enter into shared service arrangements with particular service providers designated by the Minister of Education.

RECOMMENDATION:

That the BCSTA request the Government of BC withdraw the sections of Bill 11 that override the authority of democratically elected Boards of Education. Specifically where Bill 11 adds new provisions which broaden the Minister's authority to issue administrative directives, where Bill 11 would amend the special advisor provision and where shared service providers are designated by the Minister of Education.
