# RE: Exempt Staff Wage Freeze

As your Ministries are aware, school district management and exempt staff have received zero wage increases since 2009 -- over the past six years. During that time both provincial teaching and CUPE staff have deservedly received modest wage increases that have helped them to combat inflationary cost of living increases.

Practically, the failure by government to recognize that management and exempt staff both need and deserve a wage increase creates a financial imbalance amongst our employee groups and makes attracting and retaining the educational leaders vital to a strong public education system difficult.

Ethically, our district management and exempt staff deserve the same opportunity to maintain their declining standard of living with a wage increase in keeping with that of the rest of our employee groups.

Our Board feels strongly that this wage freeze must be lifted to ensure that district management and exempt staff be treated fairly and respectfully and that Boards have the ability to attract and continue to retain quality leaders. To that end our Board carried the following motion at our February 10<sup>th</sup>, 2015 public meeting:

"That the Board of Education write a letter to the Minister of Education with a copy to the usual stakeholders re: the exempt staff freeze.

This increase must happen and it must be fully funded by government if Boards are to preserve the integrity and viability of pubic education going forward.

RE: Request for Progress Report on the Select Standing Committee on Finance and Government Services Report on the Budget 2015 Consultations.

Once again School District 5 Board of Education was pleased to see the *Select Standing Committee on Finance and Government Services* (SSCFGS) recognize the need for government to adequately address the educational funding needs as presented in their *Report on the Budget 2015 Consultations*.

We were heartened to note that education was the 2015 top priority according to this year's report.

Each year the SSCFGS solicits valuable public input from across the province in order to make recommendations to government. While each year's report is easily accessible, information on actions developed to address these recommendations –if indeed such actions are developed—is not.

Our Board wrote you on October 27<sup>th</sup>, 2014 requesting a progress update on the 2014 SSCFGS. On February 11th, 2015 our Board once again requested a progress update and urged government to take action as regards recommendations 22 – 36 from the *Report on the Budget 2015 Consultations* from the SSCFGS.

To date we have received no response and can only assume one is forthcoming.

In keeping with these letters, at the February public Board meeting School District 5 (SD5) Southeast Kootenay Board of Education carried the following motion:

"That the Board of Education write a follow-up letter to the Minister of Finance with a copy to the usual stakeholders requesting a progress update on recommendations 22 – 36 from the Report on the Budget 2015 Consultations from the SSCFGS."

Our District, along with many other Districts in BC, continues to experience the eroding effects of insufficient funding that does not address inflationary cost increases, ageing and inefficient school building upkeep and replacement, new initiatives such as trades and technology and increasing demands in the areas of special needs and literacy.

As we see nothing in the 2015 provincial budget that appears to address any of the SSCFGS recommendations, our Board would like to know what specific actions the government –and your Ministry in particular—has developed to address these fifteen important recommendations to restore education funding to a level that supports the basic needs of public education in BC.

Thank you in advance for your prompt response to this important issue.

Dear Minister Fassbender:

At the Revelstoke Board of Education meeting of February 25<sup>th</sup>, 2015, Trustees reviewed the recent provincial budget announcement. It is clear that protecting programs and services to students, in the face of increased costs and a lack of funding to meet those pressures, will be even more challenging than in previous years.

Factors that have had an impact on the projected shortfall include the loss of Funding Protection, teacher salary increments, increases to statutory pension and group benefits, costs associated with the New Generation Network, increased utility costs, and the announced reduction in administration.

Our Board takes pride in the supports available for students through the provision of enhanced educational assistant allocations; processes to ensure class size and composition are addressed effectively, and sustained specialist teacher positions to support the diverse needs of our learners.

We have reduced expenses in all areas not directly related to student learning to protect the learning conditions in our classrooms. Further reductions will have an impact on the learning conditions in our classrooms. There is an immediate need for an increase in funding to address the widening the gap between revenues and expenses. We call on government to demonstrate a commitment to public education by allocating funding that reflects increased expenses related to conditions outside of our control.

### RE: Provincial Budget Announcement

The Central Okanagan Board of Education is extremely disappointed in the recent Provincial budget announcement. Our school district has made significant cutbacks as a result of previous budget reductions, and now faces further cuts for the 2015/2016, 2016/2017 and 2017/2018 school years. It is unavoidable that further reductions will affect each and every student within the Central Okanagan School District.

In recent years, we have faced service reductions that have affected the classroom both directly and indirectly. The requirement for further cuts will only compromise the District's ability to deliver programs and services to our students. This recent Administration Reduction Target is an uneven penalty to School Districts. Like Central Okanagan, many districts have already made those tough decisions in previous years. As we complete the budget analysis we will forward you supplementary information that details the reductions that have already been made. For the Board to have to go deeper in administration could compromise the ability to effectively implement education initiatives in the School District. We request that the Government reconsider the required administration reduction targets and renew the funding levels of the public education system in British Columbia.

Dear Minister Fassbender,

The Chilliwack Board of Education respectfully requests that the Ministry of Education immediately withdraw the compensation freeze and provide the necessary funding to Boards for management and exempt staff compensation.

The recent negotiated settlement provided teachers in our province with salary increases of 2% on September 1, 2014, and 1.25% on January 1, 2015. From July 1, 2006, through to January 1, 2015, teachers will have had salary increases of over 9.5% greater than school based administration and excluded staff, as well as other improvements to their benefit plans. The BCPSEA Compensation and Employment Standards Policy specifies that there will be sufficient differentiation of compensation between the various levels of the organizational hierarchy and, particularly, between supervisory positions and those paid to the individuals supervised. The highest paid teachers in Chilliwack School District will now be earning a greater salary than our lowest paid vice principals. The additional increases to the end of the teacher contract further compounds the compression issue faced by management and exempt staff.

The matter is truly urgent as recruiting new leaders to assume the responsibilities and challenges without adequate recognition in compensation is becoming very difficult. Please assist us in assisting you in achieving your goals for public education by recognizing the important and critical role of our management and exempt staff.by dealing with this compression issue immediately.

Dear Minister Fassbender:

The "administrative savings" of 54 million dollars that the provincial budget has required of the school districts will put extreme hardship on the students and families of British Columbia.

Our district is small and every dollar is significant to us. I will not detail the many cuts we have made as they are no different from those well articulated to you in the past few weeks by many school districts. We have had to find approximately half a million dollars in each of the last two years just to keep our schools able to offer the same programs. These savings have been necessitated due to rising costs that have been mandated by your administration and include increases in hydro rates, MSP premiums, WorkSafeBC premiums and the unfunded CUPE agreement of two years ago. We also have a rising number of students with unique needs and the costs of serving these students are greater than the funding provided by government. These costs are not a one-time strain and continue to stress our budget year after year.

In our district, we made an extraordinary effort the past year to reduce our energy use and have tracked the savings. We estimate that we have saved the equivalent of a teacher's salary. We have committed to get those funds back into student support. Now you have insisted we send that and more back to you as a claw back in this year's budget.

The stress of constant reductions in budget is extremely hard on our staff, as many don't know if it will be their pay cheques that will be lost or reduced. Yet in the media they read about increases and renewals to contracts for consultation and the premier's ever-increasing communication staff. Where are your efforts at belt-tightening in your ministry?

Minister, I must ask some personal questions of you, not only on behalf of trustees but on behalf of parents who are constantly fund-raising so their children can have a field trip or a guest speaker at their school. I ask also on behalf of our teachers who bring their own materials to school because we can no longer supply them adequately and on behalf of principals who work unspeakably long hours ensuring schools are excellent on ever shrinking budgets.

How can you talk of support of education in British Columbia and refuse to treat the school districts with respect?

I witnessed you sign a memorandum of understanding with the BCSTA in early December. In that document, you agreed to communicate and collaborate with districts. Twice since then, with cuts to adult education program funds and with February's budget requirements, you have delivered blows to the operations of BC's school districts without any discussion or notice. Your approach clearly demonstrates a lack of respect.

Why did you sign that Memorandum of Understanding if you can't or won't abide by it?

I ask these questions on behalf of many in our communities, but most of all on behalf of the children and families who need our school system to deliver healthy, positive educational opportunities. I urge you to reverse these cuts and increase education funding so the students of our province can grow up with good basic skills to enter jobs and careers that government claims to be creating for them.

The Board of Education of School District No.46 (Sunshine Coast) passed a motion on March 10 to write to request removal of the requirement from the provincial budget that "administrative savings" of \$54 million over two years be found in the budgets of the sixty school districts in the province.

Each year for several years, our district has had to run our 14 schools on less money due to rising costs passed on to us from the province. Just a few examples are increases in hydro, MSP and WorkSafe BC premiums, and the unfunded salary increases for CUPE employees two years ago. Even in a small district with approximately 500 employees that means we struggle to find savings of approximately \$500,000 each year to ensure cuts have minimal effect on student learning. Any administrative savings were used long ago and our current administrative costs on a \$35 million budget are about 4%.

Each fall we send input to the Select Standing Committee on Finance and Government Services about the need for additional funding for programs in the K–12 sector and enhanced support for special needs and trades programs. In the past two years, the standing committee has agreed and included those needs in their report. In the past two years, those needs have not been reflected in the provincial budget or in the allocation from the Ministry of Education. We strongly urge you to change this approach and follow the recommendations of the standing committee to address education in the province.

Our provincial education system is at very serious risk and it appears you are balancing the budget on the backs of the weakest: those children and families who need public education to improve their lives and become fully engaged, productive citizens. How can young people get the basics to prepare for jobs in industries your government is inviting to our province if they don't get full support and learning opportunities in their early schooling? Our school system does a remarkable job on a very lean financial base.

We urge you to find savings at the executive level in Victoria and leave education funds in education where those dollars can help students. A small shift in priorities from your office could make a difference in many communities. Reconsider the administrative claw back from school districts and let us continue to manage efficient, strong education programs in our communities.

## **Re:** Excluded Staff Compensation Freeze

The Board of Education of School District No. 46 (Sunshine Coast) understands that the freeze on compensation rates for excluded staff, in place for several years, may be lifted by your Ministry after March 31, 2015.

We want to inform you that we would applaud and appreciate a decision to remove this freeze on compensation rates. Our excluded staff, including principals, vice-principals and senior district staff, has not had an increase in pay rate since 2009.

During the past six years we have seen 6.5-7.75% increases for our CUPE and teaching staff and their agreements commit to further increases for the coming years. This puts the district as an employer in the awkward position of having teachers at the top of the scale with a pay rate that is approaching our new vice-principals.

We need to manage our human resources recruitment and compensation to keep the best talent in our district and attract strong candidates from elsewhere when needed.

Thank you for considering the removal of the compensation freeze for excluded staff. We look forward to an announcement of your decision.

The Board of Education also requests that the Government of British Columbia address the public education recommendations from the Report on the Budget 2015 Consultations, Select Standing Committee on Finance and Government Services, as follows:

- 22. Provide stable, predictable, and adequate funding to enable school districts to fulfill their responsibility to provide continued equitable access to quality public education, and to meet required repair and maintenance needs.
- 24. Provide support for proposed new K-12 initiatives such as personalized learning and enhanced trades and technology training.
- 25. Provide resources to identify and address the growing number of students with special needs and those with minimal English language skills.

As stated previously in our letter dated June 27, 2014, to Premier Clark and Minister Fassbender, our school district has met past funding challenges, closing twenty-four schools, restructuring learning delivery and downsizing administrative functions to ensure all available resources would be directed to our students and our classrooms.

Our district does not have "low-hanging fruit" available for easy picking and our track record of structural action related to the primacy of classroom learning is proof of the difficult and serious approach taken over time in School District No. 57. It is imperative that you rescind your decision in recognition of the efforts our Board has taken in the past 12 years to meet the education funding shortfalls of your government.

Our district provided input to the Select Standing Committee on Finance and Government Service. We concur with the committee's recommendations and demand that you provide needed funding to meet the recommendations critical to learning for youth in our province.

Premier and Ministers, our district is striving to provide a high quality education for our students, our future citizens and leaders of tomorrow. We urge you to rescind ill-conceived cuts and provide funding needed to realize our joint goals of educational excellence for our children.

At the Board of Education meeting on January 27, 2015, the Board discussed the impacts of the Ministry's policy change regarding funding for adult graduated students taking academic upgrading courses.

The Board is concerned about the negative impact this change will have on vulnerable adults in our community who need the opportunity to access tuition-free academic upgrading in order to improve their employment opportunities and gain the skills to be in line for jobs in the growing BC economy. This policy change seems to run counter to the goals of BC's Skills for Jobs Blueprint, to make sure that British Columbians have a plan that takes them from high school through post-secondary education and right into the workforce. The Education Guarantee provided support to those who are struggling to gain a foothold in the job market or who face unique challenges such as single parents, adults-at-risk, persons with disabilities and aboriginal people.

We were encouraged at a Vancouver Island School Trustee Association meeting last year to hear you speak about the role of Trustees and the co-governance relationship between Boards of Education and the Government. # Re: Funding Shortfalls

School trustees, district administration, teachers, support staff, parents and students were hopeful that the latest provincial budget would reflect the recommendations made by the Select Standing Committee on Finance and Government Services as per the "Report on the Budget 2015 Consultations". Unfortunately, this hope was short lived as provincial budget announcements indicated that school boards across the province will be required to find a total of \$29 million in administrative cuts in the next school year's budget and an additional \$25 million in the following year, and that these cuts must be sustained for future years. These cuts are in addition to addressing the pressures created by rising fixed costs, including rising electrical rates, medical service plan premiums and Next Generation Network.

For the past several years, school boards have been told to "trim fat" and find efficiencies without impacting the classroom. In fact, since the 2009-2010 school year this district has cut approximately \$6,250,000 from our operating budget. The impact of these cuts would have been greater if our operating budget was not supplemented by revenues generated by technology initiatives and our International Student Program.

Specifically, we have made budget cuts to the following areas:

B	Reduction to maintenance and custodial staffing	\$392,000

To clarify, these cuts do not reflect the reduction in staffing due to declining enrolment or reductions in formula driven operating costs, such as learning resources. Without adequate funding, our district has been put in the position of reducing operational necessities and services to students. We continue to feel substantial financial pressure on our ability to meet the growing needs of our students and our aging facilities. There simply is no more "low-hanging fruit" left in School District 67. In fact, the "fat has been trimmed and we are down to the bone".

We are disheartened with the government's apparent lack of understanding of what it takes to deliver education. As such, perhaps the attached article titled "Province's school-budget calculations useless", by Geoff Johnson will assist in understanding the expectations put on the administration of education, business, human resources and labour-relations responsibilities.

We urge you to reconsider the direction given to Boards to find additional reductions on an already financially stressed system. It is only a matter of time until the system will begin to implode and that the effort and work put forth to make the public education system one of the best in the world will all be for naught.



Geoff Johnson: Province's school-budget calculations useless

The latest government-generated problem facing B.C.'s beleaguered public schools and their communitybased boards of education is where to find the \$54 million the provincial government wants to retrieve from local administration.

A review of the Education Ministry's own figures regarding costs of school-district administration in the 60 school districts, the "low-hanging fruit" described by the premier recently, reveals something politicians might not understand.

School-district administration costs, which seem to be the target of the latest "ready, fire, aim" utterances about public education coming out of Victoria are identified in detail in Function 4 of the ministry allocation system.

Let me explain.

Function 4 includes all programs related to district governance and the administration of educational, business, human resources and labour-relations activities.

Business administration includes budgeting, financial accounting, legal and labour-relations costs, purchasing, housing and human-resources administration.

None of these activities occur at the school level, but without these activities it is unlikely that school districts and classrooms would continue to function effectively.

Also included in Function 4 are instructional staffing allocations, new programming (usually emanating from Victoria) and BCeSIS costs.

BCeSIS is the extremely expensive, disastrously flawed centralized data system initiated by the Education Ministry to collect and process data on all students. It has cost school districts large amounts of unfunded staff time just trying to get it to work.

Function 4 has in recent years, and with no additional funding, seen staff diverted from in-district classroom instructional support to filling out reports demanded by the provincial government: the District Literacy Report, the Carbon Offset Report, the Aboriginal Education Report, the Erase-Bullying Report, the Achievement Contract, the Class Size and Composition Report and so on.

Arrow Lakes, which according to ministry figures has one of the higher percentages of its operating budget committed to district administration, has a staff of 2.25 people to do all this stuff. There again, we see misleading arithmetic at play when people use percentages. The smaller the operating budget, the larger percentage of it 2.25 people will appear to be.

In fact, when considering district administration as a percentage of school-district budget, the size of a district as measured by student enrolment, not geography, is significant.

Smaller, mostly rural, districts of as many as 2,000 students average about 7.6 per cent for district administration, while larger, mostly urban, districts of more than 9,000 students with much larger operating allocations average about three per cent.

Ministry figures indicate it costs more to run a school district in places such as Arrow Lakes, Stikine, Nisga'a and Central Coast. Those districts chalk up, as a percentage of their operating budgets, three times the cost of running larger urban districts such as Surrey, Delta and Burnaby.

Given the unique additional costs of administering more remote rural districts compared to conveniently located urban centres, the provincial average means nothing at all. It is not a useful calculation.

In the world of business, where executive decisions are justifiably driven by considerations of profit and the bottom line, there are reasons why big grocery chains and financial institutions do not locate in every small town throughout the province. If people in those communities want those services, they'll travel to the larger centres to get them.

Public education does not work like that, or shouldn't. Smaller towns and communities don't want kids travelling 60 kilometres by bus each way to a larger centre's schools in a northern winter to theoretically save a few provincial dollars in school-district administration.

The longest teacher strike in the province's history is over. The schools are back to normal in 60 school districts. Running a public education system in B.C. costs what it costs and, given the results, is still a bargain.

The Board of Education, School District No. 71 (Comox Valley) has considered the recent provincial budget announcement that contained a \$29 million administrative savings for the 2015/16 budget, which will increase to \$54 million the following two years.

The Comox Valley school district has experienced enrolment declines for many years and has been pursuing organizational efficiencies in response to the associated decline in government grants. As a district in funding protection, we are working to strategically align our budget towards a time when we are no longer receiving transitional grants. These adjustments have involved numerous school closures, the reduction of direct and indirect support for students, participation on shared service activities, as well as ongoing reductions to our administrative staff. As a part of the CUPE Cooperative Gains era, we were required to process additional savings to allow our support staff to receive a well deserved wage increase.

Given the Comox Valley school district's budget reality over the past several years, it is difficult for the Board of Education to understand how government could determine there are further administrative savings to be realized. In an attempt to better understand the basis of government's decision, we are respectfully requesting that you respond to the following two questions:

- 1. What data or matrix did the Ministry of Finance and/or Ministry of Education utilize to determine that School District No. 71 (Comox Valley) has the capacity to make an administrative savings reduction to cover its share of the provincial budget reductions?
- 2. Based on the data or matrix utilized above, at what point has the Ministry of Finance and/or Ministry of Education determined that School District No. 71 (Comox Valley) will reach its capacity to affect administrative savings?

## Re: <u>Co-Governance Memorandum of Understanding</u>

On behalf of the Board of Education for School District No. 78 (Fraser-Cascade) I am writing to express our concern regarding the short timeline for consultation on the BCSTA/Ministry of Education Co-Governance Relationship Memorandum of Understanding.

Our Board shares the concerns identified by the Sunshine Coast Board of Education in its letter to you dated December 2, 2014, that the short consultation process means the language in the MOU is not necessarily representative of what boards across the province would want in such an agreement. Furthermore, with the agreement being approved and signed in December, there was little opportunity for newly elected trustees to learn more about the co-governance relationship and to review and offer their comment prior to it being finalized.

As Sunshine Coast Board of Education points out, the "Whereas" section of the Agreement makes reference to cooperation and a harmonious, collaborative, coordinated approach yet this is not always the reality. A recent case in point was the introduction of the proposed policy change that would have districts with excess cash having to pay up to half the cost of capital projects. This was introduced without providing an opportunity for boards of education to discuss or provide feedback into the proposed change, despite it having a direct impact on board operations.

As the MOU is to be reviewed annually, or as circumstances require, we hope that BCSTA and the Ministry will revisit the agreement in this year, and provide another consultation process with sufficient lead time thereby allowing the opportunity for new boards to provide greater input.

On behalf of the Vancouver Island School Trustees' Association I am writing to express our disappointment in your characterizing our valued employees as "low hanging fruit".

Your recent funding announcement identifying total administrative savings of \$54 million over the next two years can be summed up as both devastating and detrimental to your government's BC Education system. This willful and blatant disregard for our business experts and educational leaders will most certainly be felt throughout the system for years to come. This not only targets our senior and exempt staff who remain under a multi-year wage freeze but also our CUPE employees who have borne significant reductions due to the ongoing underfunding of education.

For over a decade school districts have made extensive financial adjustments that include four-day school weeks, two-week spring breaks, reduced clerical staff support, transportation route and fee for service adjustments, in addition to financial liabilities off-loaded onto school districts by your government. Custodians and grounds keepers have been reduced from 12 month to less than 12-month employees. We have embraced shared services where meaningful cost saving measures have been realized through fleet vehicle purchasing plans, fuel consortiums and purchasing cards. Boards of Education have assessed expenditures and exercised due diligence to eliminate costs in all areas while doing their best to maintain classroom learning environments. Innovative ideas and solution are born from collaboration and sharing of knowledge. We ask that you consider the impact that this will have over the longer term. Our children's education is the key to our future success economically as a province.

#### **BACKGROUND/RATIONALE**:

On April 2, 2015 the Ministry of Education announced the 2015/16 Annual Facility Grant ("AFG") Funding. (Attachment A)

For 2015/16 School District No. 42 (Maple Ridge-Pitt Meadows) will receive \$2,389,658 as AFG funding.

The AFG funding provided by the Ministry of Education is intended for annual facility projects required to maintain facility assets through their anticipated economic life and to prevent premature deterioration of these assets.

There are two components to the AFG funding: a capital bylaw component and an operating component. School districts must provide the Ministry of Education with a 2015/16 AFG Expenditure Plan that includes a list of all AFG projects and expenditures to be undertaken between April 1, 2015 and March 31, 2016. The proposed 2015/16 AFG Expenditure Plan for School District No. 42 is included in Attachment B. This expenditure plan will be incorporated in the 2015/16 Preliminary Budget Bylaw that will be approved by the Board in May 2015.

The operating portion of the 2015/16 AFG funding is \$561,550 and will be distributed to school districts as targeted funding and reported as a Special Purposed Fund. A portion of the operating AFG for 2015/16 will be retained by the Ministry to continue funding the implementation of Capital Asset Management Services (\$44,051) and for Next Generation Network (\$239,857).

In order to access the balance of \$2,112,016 allocated to the Capital Portion of the 2015/16 Annual Facilities Grant the Board is required to adopt a standard Capital Bylaw. Capital Bylaw No. 126896 is included in Attachment C.

#### Re: 2015/16 Annual Facility Grant

The Ministry will provide an Annual Facility Grant (AFG) allocation totalling \$121.386 million in 2015/16 to fund maintenance and repairs of capital infrastructure in school districts. This year, the AFG funding allocation will be made up of \$25.196 million from the Ministry's operating budget and \$96.190 million from Government's capital funding allocation. (Please see attached 2015/16 Annual Facility Grant Allocation table.)

In 2015/16, \$2 million will again be allotted from the operating portion of the AFG funding allocation to support Capital Asset Management Services (CAMS). School districts are expected to utilize the facility condition assessment information for their facilities in the CAMS database to help guide their AFG spending decisions.

A further \$10.89 million from the operating portion will be used by the Ministry to fund start-up costs of upgrades, which began in 2014/15, to the Provincial Learning Network (PLNet) for the Next Generation Network (NGN).

Each school district must provide the Ministry with an AFG Expenditure Plan for 2015/16. Please note that the AFG Expenditure Plan template has been revised from last year to gather more specific AFG expenditure information. (see attached spreadsheet.)

The template requires all work using AFG funds that is planned between April 1, 2015, and March 31, 2016, to be identified by facility. (Please note that work using any AFG funds carried over from 2014/15 should not be included in the AFG Expenditure Plan for 2015/16.) School districts must again indicate whether the planned AFG work will specifically address a VFA requirement as identified in the most recent Facility Condition Assessment (FCA) undertaken by a VFA Canada assessment team. However, those VFA requirements must be further attributed with a VFA Uniformat Code, as may be chosen from the pull-down menu provided. A separate tab has also been included that provides additional detail regarding the sub-categories of Uniformat codes used for an FCA and should help to make the most appropriate selection from the pull-down menu.

Notably, the Actual Cost column, coloured in blue, is not to be used in the initial submission of the AFG Expenditure Plan. School districts must submit this additional information after March 31, 2016, when the value of completed AFG work for individual facilities is fully known.

This year's net AFG operating allocation of \$12.306 million (\$25.196 million less the CAMS and PLNet contributions) will be paid to school districts in one installment in July 2015. Each school district will be granted a single Certificate of Approval (COA) for its portion of the \$96.190 million capital allocation. A standard capital bylaw adopted by the board of education, using the project numbers provided in the attached table will be required prior to the issue of the COA. In accordance with Provincial Treasury policy, draws against the COA should not occur until capital project expenditures have been made.

School districts are requested to submit their AFG Expenditure Plan to their Planning Officer as soon as possible. School districts will receive their COA for AFG as soon as they have submitted the required capital bylaw and spending plan. Please contact your Planning Officer if you have any questions regarding the new AFG Expenditure Plan template.

School districts are encouraged to maximize all AFG spending for capital-related maintenance work that meets the criteria for capitalization and to follow the AFG policy, which can be found at the following link:

Please be reminded that all such planned AFG work must be completed by March 31, 2016, when the COA will expire.

#### **BACKGROUND/RATIONALE:**

On October 1, 2014, the Ministry of Education approved capital funding of \$2,000,000 for the Maple Ridge Secondary School Building Envelope Remediation Project (Attachment A).

Based upon a revised reduced budget from BC Housing of \$1,150,000 (Attachment B) and approval from the Ministry of Education to proceed, based upon the revised reduced amount, a standard Board capital bylaw is now required to access this funding. (Attachment C)

The general scope of the work to complete this project and project costs are listed below:

Work in this contract consists of targeted building envelope repairs at Maple Ridge Secondary School. In general, the work includes but is not limited to the following:

- 1. Stucco cladding replacement of all walls on the east and west elevation of the Science Wing, as shown on the plan and elevation drawings. The existing cladding is to be replaced with new rain screen stucco.
- 2. Structural repairs to wood/steel framed walls, located within the building envelope area of repairs.
- 3. Complete replacement of windows on all walls within area of work shown on the plan and elevation drawings.
- 4. Replacement of the glass canopy located over the West Entrance of the Science Wing.
- 5. Replacement of metal cladding over the canopy located on the East elevation of the Science Wing.
- 6. Tile cladding replacement of walls on the west elevation Gymnasium, as shown on the plan and elevation drawings. The existing tile cladding is to be replaced with new rain screen cultured stone cladding that matches appearance/color and texture of the South Science Wing Entrance Masonry Wall.
- 7. Stucco cladding replacement of all walls on the east, north and west elevation of the Gymnasium, as shown on the plan and elevation drawings. The existing cladding is to be replaced with new rain screen stucco.

- 8. Replacement of Metal cladding and underlying sheathing on the Metal bulkhead on west, north and east elevation of the Gymnasium, as shown on the plan and elevation drawings.
- 9. Stucco cladding replacement of all walls on the north and east and west elevations of the Gymnasium, as shown on the plan and elevation drawings. The existing cladding is to be replaced with new rain screen stucco.
- 10. Structural repairs to steel framed walls, located within the building envelope area of repairs.
- 11. Replacement of two roof level skylights as shown on drawings.

The project budget confirmed by BC Housing and Ministry of Education staff is \$1,150,000:

Consulting \$56,552 Construction \$856,000 Contingency & Other Costs \$237,448

The project was tended and Peak Construction Group is the successful bidder. Construction time frame is estimated to be twenty-five weeks. Construction could start as early as the end of April 2015 with the gym section. This would present fewer issues with occupancy. The inside work to be completed over the summer break.

#### **BACKGROUND/RATIONALE:**

This agreement is the result of ongoing engagement by members of the Aboriginal community and School District No. 42. We have held regular advisory meetings, band meetings, staff meetings, and district meetings along with extensive personal and electronic communication to maintain and review our current agreement, and to develop our newest agreement. We have revisited this agreement several times since May 2013, and have asked for feedback and input from staff, parents, students, and our community partners. The goals contained in this agreement represent input from all stakeholders: School District No. 42 staff, students, parents, and members of Katzie First Nation, Kwantlen First Nation, The Golden Ears Métis Society, and the Fraser River All Nations Aboriginal Society.

Following is an outline of formal meetings and discussions that took place:

May 2013 Advisory meeting: initial discussion around vision and direction

Oct. 2013 Advisory meeting: initial discussions about revisions for our next Enhancement Agreement

Feb. 2014 Advisory meeting (we held two meetings: one in the afternoon and one in the evening): discussion about revisions to our Enhancement Agreement, suggestions for future goals, what was working and what was not working for our students.

Spring 2014: Consultation with Katzie First Nation, Kwantlen First Nation, and Golden Ears Metis Society. We asked for parent meetings to discuss suggested revisions to our Enhancement Agreement.

May 2014 Advisory meeting: (I held two meetings: one in the afternoon and one in the evening): We reviewed notes and suggestions for revisions to date. Further discussion took place about specific wording for goals.

Oct. 2014 Advisory: We reviewed our draft agreement to date and made further suggestions to our goals.

Jan. 2015 Planning Day: Detailed review of goals with Aboriginal Education staff, and revisions to wording. Some discussion about strategies to support goals.

2015 Winter Advisory: Review of updated proposed wording from January 2015 staff review.

Feb. 2015: Draft document sent to Colleen Hannah and Ted Cadwallader from (Aboriginal Education Enhancements Branch) for initial review and feedback.

Received feedback from Harry Dhillon on behalf of District No. 42 Senior Staff.

March 2015: Met with Education Council of Kwantlen First Nation to review our draft agreement, at their request.

March 2015: Draft Enhancement Agreement was posted online and feedback was invited from all parents (via Parent Portal email and via notice sent home with all students)

March 2015: Ron Lanzarotta and Colleen Hannah met to review feedback from Ministry. Feedback from Harry Dhillon on behalf of District No. 42 Senior Staff.

March 2016 Special Advisory: Last round of feedback and discussion of latest draft including feedback from Ministry and Senior Team.

The intent of this agreement is to facilitate excellence and success for all Aboriginal learners at all grade levels. The partners to this agreement will:

- Support all Aboriginal students in our schools.
- Cultivate a learning community where Aboriginal students experience safety, respect and a positive sense of belonging.
- Engage in collaborative decision making regarding matters involving Aboriginal education in the School District.
- Continue to review the goals and objectives of the Aboriginal Education Enhancement Agreement to ensure it is a living, evolving guide for Aboriginal student success.

#### **RECOMMENDATION:**

THAT the Board approve the 4th Aboriginal Education Enhancement Agreement and authorize the Board Chair, the Superintendent, the Secretary Treasurer, and the Chair of the Aboriginal Advisory Committee to execute the agreements on its behalf.

#### **Background Information**

School District No. 42 (Maple Ridge – Pitt Meadows) lies within the traditional territory of the Katzie First Nation and the Kwantlen First Nation. The school district serves all Aboriginal students within the communities of Maple Ridge and Pitt Meadows. School District No. 42 was the third district in British Columbia to sign an Enhancement Agreement between the District, the Aboriginal Community and the Ministry of Education in 2000. Our second agreement was in effect from July 1, 2005 to June 30, 2010, and our third agreement has been in effect from July 1, 2010 until June 30, 2015.

On July 1, 2015, we will begin our 4<sup>th</sup> Enhancement Agreement, which will be in effect from July 1, 2015 until June 30, 2020.

This agreement is the result of ongoing engagement by members of the Aboriginal community and School District No. 42. We have held regular advisory meetings, band meetings, staff meetings, and district meetings along with extensive personal and electronic communication to maintain and review our current agreement, and to develop our newest agreement. We have revisited this agreement several times since May 2013, and have asked for feedback and input from staff, parents, students, and our community partners. The goals contained in this agreement represent input from all stakeholders: School District No. 42 staff, students, parents, and members of Katzie First Nation, Kwantlen First Nation, The Golden Ears Métis Society, and the Fraser River All Nations Aboriginal Society.

#### **Principles of This Agreement**

The intent of this agreement is to facilitate excellence and success for all Aboriginal learners at all grade levels. The partners to this agreement will:

- Support all Aboriginal students in our schools.
- Cultivate a learning community where Aboriginal students experience safety, respect and a positive sense of belonging.
- Engage in collaborative decision making regarding matters involving Aboriginal education in the School District.
- Continue to review the goals and objectives of the Aboriginal Education Enhancement Agreement to ensure it is a living, evolving guide for Aboriginal student success.

#### <u>Aboriginal Education Advisory Committee Terms of Reference</u>

The Advisory Committee represents and supports the collective responsibility for promoting success for all Aboriginal students in School District No. 42. This group meets three (3) times each school year: in the Fall (October), Winter (February) and Spring (May). Additional meetings for discussion and consultation can be organized as needed throughout the year.

The mandate of the Aboriginal Education Advisory Committee is:

- To provide a forum for an open, honest exchange of information and ideas.
- To make recommendations and suggestions which will assist the School District in better meeting the needs of Aboriginal learners.
- To counsel School District No. 42 in matters pertaining to Aboriginal culture.
- To serve as resource people for School District No. 42 and for the organizations represented on this Committee.
- To review our Aboriginal Education Enhancement Agreement on an annual basis, and to recommend or approve yearly strategies that support our goals.

#### **Considerations That Have Influenced Our Thinking Along the Way**

- School District No. 42 has had 5 different superintendents between the signing of the first Aboriginal Education Enhancement Agreement and the upcoming signing of our fourth Aboriginal Education Enhancement Agreement. Each superintendent has brought different perspectives and priorities to the overall education program and philosophy in our district.
- We have also had 4 different principals of Aboriginal Education. Each person serving in this position has brought different perspectives and priorities to the Aboriginal Education department.
- Many of the previously utilized assessments for literacy and numeracy are no longer being administered on a district-wide basis. One of our district goals is to establish effective assessments for literacy and numeracy competencies. This will influence the type of data we collect.
- The Foundation Skills Assessments (F.S.A. s) have ceased to be valid measures of literacy and numeracy due to high numbers of students not participating.
- The number of self-identified students in the Aboriginal Education department climbed steadily until the 2014-15 school year, at which point we experienced a slight decline. Although our February 17, 2015 "1701" tally shows another increase in self-identified students, we are still projecting a net decrease in numbers over the next few years. This is due to lower numbers of incoming self-identified kindergarten students compared to numbers of outgoing grade 12 students.
- During the term of our current Aboriginal Education Enhancement Agreement the Aboriginal Education department chose to adjust its practice of how supports are delivered to students. The "Case Management" model was introduced at the secondary level during the 2011-12 school year. In this model individual student needs determine priority supports. Our supports are still guided by the goals in our Aboriginal Education Enhancement Agreement; however, we are striving to deliver supports in a much more individualized manner. Beginning with the 2012-13 school year, we also implemented this approach at the elementary level.
- Graduation rates have improved in recent years. We attribute this, in part, to the implementation of the Case Management model.
- As our students have experienced greater success their needs and desires for support have changed. We expect to further increase our graduation rates,

which could continue to influence both the amount and type of support we provide to students.

- School District No. 42 has changed its reporting practice from letter grades in intermediate grades. Elementary students are now assessed on general competencies and student progress is communicated through student led, portfolio-based conferences.
- Each year we experience a high degree of movement across schools, or in / out of the district. This makes it difficult to track grade-to-grade transitions with any sense of accuracy. We have found our Case Management model has assisted us with tracking movement between schools or districts, and has also allowed us to be more aware of students who make choices to drop out of the regular school program. We are able to communicate such changes in a timely manner to our Alternate Education program in an attempt to continue supporting our students.

#### <u>Underlying Beliefs That Have Shaped Our Current Goals</u>

# Belonging allows Engagement Engagement supports Achievement Achievement enhances a Life of Value

(Karen Edwards, 2015: supported by thesis research)

Students and their families develop a sense of belonging to various groups, or communities. We see schools as one of these communities: each school is a community in which all members – students, parents, and staff – are constantly learning and developing. To maximize the learning and growth potential of individual members within a school community, their bond to school must be strong and healthy. This is accomplished by developing high quality, trusting relationships, and by providing educational programs that support individual learning styles and interests.

Each person in the school community must be seen as inherently whole and can be envisioned as a blend of spirit, mind, emotion, and body. These values are described in the Medicine Wheel teachings and form the foundation of the goals in this Aboriginal Education Enhancement Agreement. Students in our schools need opportunities to develop in all facets: spirit, mind, emotion, and body. This includes the broad learning areas of:

- Sense of self (interests/gifts/talents/strengths);
- Healthy bodies and relationships;
- Self-management skills (i.e. confidence, resiliency, goal setting);
- Knowledge and academic skills.

Families, communities, and schools must work together to support students as they grow and develop in each of these four areas. Although the Aboriginal Education department, and School District No. 42 in general, strives to support the whole student, our primary focus in schools is on intellectual, social, emotional, and physical growth. The goals in this Aboriginal Education Enhancement Agreement represent our

commitments in these areas. We will support students based on their individual needs through a variety of structures and strategies.

#### 2015 - 2020 Goals and Rationale

The following goals represent overarching commitments and priorities we will pursue throughout the duration of this Agreement.

The Aboriginal Education department staff will develop a plan for specific strategies and assessments each year based on a review of student progress. We will also maintain detailed documentation of our yearly plan. We will share our plan with District and school staff each year and will explain how we can:

- 1. Provide direct support to Aboriginal students.
- 2. Provide support to schools so they are better able to support the goals contained in this Aboriginal Education Enhancement Agreement through their daily practice.

Based on feedback from our partners, we acknowledge that successful school completion for our students incorporates both a connection to their culture and a strong sense of "next steps" in their lifelong learning path.

## Goal 1 Continue to develop a strong sense of community for Aboriginal students and families in their schools and within School District No. 42.

#### Rationale:

This goal relates to the first statement in our "Underlying beliefs" (page 9):

#### "Belonging allows Engagement"

We acknowledge a strong sense of belonging is necessary for learning to occur. We envision school communities where Aboriginal students feel a strong sense of connection to Aboriginal Education department staff, to school staff in general, and to other students. We believe this sense of connection

will lead to stronger and healthier learning, and to a broader range of involvement in both academic and extra-curricular opportunities within the school community. We believe our increase in graduation rates is directly related to the effort we make to connect with students, and assist them with staying connected to their teachers and academic requirements.

During conversations with our parent community and staff, this goal has been identified as the number one priority to continue in our 4<sup>th</sup> Aboriginal Education Enhancement Agreement. This goal is also an important one in the <u>School District No. 42 Strategic Plan: Roadmap to Excellence</u> document (page 5). Our general belief is that if students feel connected to their school they will experience higher levels of attendance and engagement, and a higher quality of learning.

In the Ministry of Education "Aboriginal Report 2009/10 – 2013/14: How Are We Doing?" the Ministry of Education Satisfaction Survey for School District No. 42 students asked the questions that follow. Aboriginal student responses are shown below:

These responses suggest we have seen an improvement in students' feelings towards school. They also suggest there is still room for improvement. In terms of awareness of Aboriginal peoples and culture, these responses indicate we still have considerable room for improvement.

We will continue to develop positive relationships between schools, staff, students, and families. This will be accomplished through the personal connections we strive to maintain, and through the many activities we offer to students. We will continue to offer cultural and historical workshops to classes and schools in all grades, and will continue to offer education to district staff about Aboriginal cultures and history.

Each year we will select "indicators of success" that best inform us about our progress in each of the goal areas. We will collect, analyze, and report on our data each year.

## Goal 2 Support and improve the quality of school achievement for all Aboriginal students.

This goal relates to the second statement in our "Underlying beliefs" (page 9):

#### "Engagement supports Achievement"

#### Rationale:

Improving graduation rates continues to be a priority goal, and although we have seen improvements in recent years, we see the need for continued improvement.

Parents have continued to support this goal and it is consistent with both district and provincial educational priorities. In collaboration with our community and district partners we will strive to provide services and supports for all Aboriginal students.

Each year we will select "indicators of success" that best inform us about our progress in each of the goal areas. We will collect, analyze, and report on our data each year.

## Goal 3 Transition Aboriginal students into their future learning, employment, and life experiences beyond the completion of their secondary program.

This goal relates to the third statement in our "Underlying beliefs" (page 9):

"Achievement enhances a Life of Value"

#### Rationale:

Feedback from our parent community suggests caution that we not simply focus on trying to increase graduation rates. Parent feedback suggests it is equally important to focus on the quality of graduation; we need to support students in developing a vision of what to do after grade 12. We coined the term "Quality Graduation" to reflect this outcome.

In the Ministry of Education "Aboriginal Report 2009/10 – 2013/14: How Are We Doing?" the Ministry of Education Satisfaction Survey for School District No. 42 students asked the questions that follow. Aboriginal student responses are shown below:

These statistics, along with feedback from parents, point to the need for us to address this goal through a variety of strategies. We realize there are many factors related to feeling "prepared" for the next steps after secondary school, and will review our yearly Implementation Plan to update strategies, based on student needs.

This goal is tied very closely to our second goal: "Support and improve the quality of school achievement for all students". However, given the specific feedback we received about this priority we felt it important to include it as a separate goal in this Education Enhancement Agreement.

Each year we will select "indicators of success" that best inform us about our progress in each of the goal areas. We will collect, analyze, and report on our data each year.

### **Appendix 1: Yearly "Implementation Plan" Timeline**

Each year we will review specific objectives related to major goals and will update them for the upcoming school year. Our yearly timeline for this process is:

June: Yearly review of student progress related to individual needs surveys.

Reflection and review of specific objectives, strategies, and progress measurements from the present school year.

Prepare our annual Department Report.

Sept. Review student needs surveys / learning inventories for new students.

Review and finalize priority objectives, strategies, and progress measurements related to our Aboriginal Education Enhancement Agreement goals for this school year. This will form the framework for our Annual Report.

Oct. Report to the Advisory Committee about this year's priority goals and objectives.

Nov. Review of student progress related to individual needs and departmental goals.



### E1. BCSTA BYLAW UPDATE

**SUBMITTED BY:** Board of Directors

**BE IT RESOLVED:** 

That BCSTA amend the Bylaws of the Association by deleting each reference to "Executive Director" and replacing it with "Chief Executive Officer".

#### RATIONALE:

Boyden Global Executive Search ("Boyden"), the search firm engaged by the Association to assist with the recruitment of the Association's Executive Director, recommended that the Association change the title of Executive Director to Chief Executive Officer. According to Boyden, the CEO title is increasingly being used by not-for-profit organizations in place of the title Executive Director. In addition, Boyden advised that utilizing the CEO title may help to make the position more attractive to prospective candidates.

### E2. TWO-YEAR TERM FOR BCSTA DIRECTORS

**SUBMITTED BY:** SD74 (Gold Trail)

**BE IT RESOLVED:** 

That Bylaw 2 be deleted and replaced with the following:

### "2. ELECTION AND DUTIES OF DIRECTORS AND OFFICERS

- a. Elections for Directors and elected Officers will take place at the Annual General Meeting.
- b. The Minister of Education shall be the honorary President of the Association.
- c. The elected Officers of the Association are the President and the Vice-President.
- d. The immediate past President, if he or she agrees to serve, will be an Officer. If the immediate past President cannot or will not serve, then this position is vacant.
- e. There will be four (4) Directors if the immediate past President agrees to serve; five (5) otherwise.
- f. The Executive Director will be the secretary-treasurer.
- g. An elected Officer will serve a term of two (2) years commencing at the close of the Annual General Meeting at which such individual is elected and concluding at the close of the second Annual General Meeting held subsequent to such Officer's election.
- h. The term of office for Directors will normally be two (2) years. However the Board of Directors may, by resolution, determine that some or all Directors' positions will have a term of one (1) year with the intent of ensuring that not all Director positions are up for election in the same year. For the purposes of calculating the duration of a Director's term of office, the term will be deemed to commence at the close of the Annual General Meeting at which such Director was elected and to conclude at the close of the first or second Annual General Meeting held subsequent to such Director's election as applicable.
- i. No person may stand for election for President, Vice-President or Director unless he or she is a trustee serving on a member Board.
- j. The President will call meetings of the Provincial Council at least twice in each year between Annual General Meetings and of the Board of Directors at least monthly. The President will chair meetings of the Board of Directors, and the President, or such person as he or she designates, will be chair of meetings of the Provincial Council. The President will appoint

- members to the Association's standing and ad hoc committees. The President will be an ex officio member of all BCSTA committees.
- k. The Vice-President will perform all duties of the President at such times as the President is unable to perform them.
- I. Notwithstanding the requirements of subsection (i), a Director or Officer whose Board ceases to be a member solely by reason of its being abolished under the *School Act* may remain in office until the next Provincial Council meeting, or Annual General Meeting, whichever first occurs, following the abolition.

#### **RATIONALE:**

Now that the term of office for school trustees is four years, a two year-term for the President, Vice-President and Directors fits in very well in that schedule, and would allow trustees elected to the Board of Directors a longer period of time to learn their roles and to accomplish their goals.

### 3. EVERGREEN/SCHOOL LEAVING CERTIFICATE

**SUBMITTED BY:** Aboriginal Education Committee

#### **BE IT RESOLVED:**

That BCSTA write a letter to the Minister of Education in support of the First Nations Education Steering Committee's recommendations around Evergreen Certificates.

#### RATIONALE:

In its December 2014 Accountability Framework Discussion Paper, FNESC recommends "that the Student Credential Order be amended to ensure only students designated special needs and on an IEP be eligible for an Evergreen Certificate. Mechanisms to monitor and support School District compliance with the new Student Credential Order should be developed as soon as possible."

The issues of graduation standards and processes are currently under review by the Ministry of Education. FNESC is concerned about the gap between Aboriginal and non-Aboriginal student achievement; especially with respect to entry into post-secondary institutions.

The Ministry of Education's "Aboriginal Report 2009/10-2013/14 How are We Doing?" includes the following statistics regarding graduation rates and entry into post-secondary institutions:

• Graduation rate from Grade 12 within 6 years of entering Grade 8 (2013-2014)

• Non-Aboriginal: 86%

Aboriginal: 62%.

School Completion/Evergreen Certificate and GED are not graduation credentials, thus limiting opportunities to enter post-secondary.

# 4. GRADUATION PROGRAM – CURRICULA GRADES 10 AND 11

**SUBMITTED BY:** SD36 (Surrey)

**BE IT RESOLVED:** 

That BCSTA ask the Ministry of Education to publish the timeline for completion of the redesigned graduation program curricula and to release draft curricula for grades 10 and 11 by September 2015.

#### **RATIONALE:**

Surrey School District is encouraged by the new K-9 curriculum. We believe that teachers are being given more freedom to teach to their strengths and to students' passions. This curriculum was developed by teams of teachers working with the Ministry of Education and creating draft curricula in several subject areas.

Components of the new K-9 curriculum were made available in October 2013 and feedback has been gathered for revisions.

The issues of big ideas, core competencies and innovation which have been incorporated into the new K-9 curriculum will be challenging to incorporate into the existing grade 10-12 graduation program where subjects are discrete and not interconnected.

We hope that the opportunities and flexibility presented in the K-9 curriculum will soon be available in grades 10-12. We believe we need a new Graduation Program to connect to the strong work that has been conducted with respect to the K-9 curriculum and we welcome a chance to know the timelines for completion of that work so our teachers can be given a chance to review its progress and to move from concepts to action.

We believe that substantial work has already been completed on the grades 10 and 11 draft curricula. We also recognize that additional time and work is required to complete the draft curricula for grade 12. We therefore request that the draft curricula for grades 10 and 11 only be released by September 2015.

### 5. SOCIAL MEDIA IN BC'S EDUCATION CURRICULUM

**SUBMITTED BY:** SD72 (Campbell River)

#### **BE IT RESOLVED:**

That BCSTA encourage the Ministry of Education to work with Boards of Education to co-develop and implement a social media component in the K-12 curriculum which would include, but not be restricted to, the topics of internet safety, cyber-bullying, sexting, and posting videos on social media sites.

#### **RATIONALE:**

Over the past several years there have been incidents of cyber-bullying which have resulted in many young people taking their own lives. Some of the most highly publicized incidents of cyberbullying are: the Amanda Todd and Rehtaeh Parsons cases, the recent video 'How to Kill Your Teacher' posted online by two elementary students in Castlegar, and the suspension of several fourth year dental students at Dalhousie University for mysogynistic posts on Facebook, to name but a few. Misogyny is "a hatred of women" (Merriam- Webster Dictionary). In addition, anecdotal evidence suggests that cyber-bullying is far more widespread than educators and parents would suspect.

It is crucial that our students understand what social media is, how it can be used appropriately and inappropriately, the power that their online posts can have, and the possible consequences, both for themselves and for those who may be victims of the inappropriate use of social media.

Our world is changing, and our schools need to address this change in a way that educates our students about the proper use of social media and the possible consequences of its inappropriate use. Further, there is a wide disparity in teacher knowledge and understanding of social media, and their abilities to provide adequate instruction in this area despite the efforts of educators in many school districts to address this serious and timely topic. For these reasons it is incumbent upon the Ministry of Education to provide a clear framework for the delivery of this information.

# 6. INTEGRATED FUNDING MODEL FOR CHILD AND YOUTH MENTAL HEALTH SERVICES

**SUBMITTED BY:** *SD44 (North Vancouver)* 

**BE IT RESOLVED:** 

That BCSTA:

Urge the provincial government to continue its work on inter-ministerial planning and supports for child and youth mental health services; and,

ask the Ministries of Children and Family Development, Education, and Health to explore the creation of 'shared-funded' centres of excellence or 'lighthouse' centres in the province where exemplars of integrated services and supports are provided to school-aged children with mental health concerns in a seamless manner.

#### RATIONALE:

The social and emotional well-being of students in our K-12 system is an essential aspect in the development of children, and contributes to the educational success of his/her pathway to graduation and beyond.

It is essential that this type of a model be directly connected to a school district as most child and youth mental health challenges are first identified in these settings, and schools have the most recent data on symptoms of challenges (e.g., attendance etc.). An additional feature that needs to be considered in such pilots is the teaching of best practices to interagency service providers such as teachers, mental health clinicians, and health providers.

A 'shared-funded' centre where parents and children have an integrated case management support minimizes wait time and procedural resistance.

Public schooling is the first point of reference for, and key access point to, concerns regarding mental illness in children and youth

Proactive and collaborative programs, designed to address mental health literacy and intervention, require the support and expertise from other Ministries outside of the Ministry of Education's jurisdiction. In order to meet all students' needs for counseling/health services, and social workers, funding needs to be integrated in building a system of care and support within our schools and communities.

To build a system that fully integrates health and community services, other Ministries play an important role, not only in developing programs but also in supporting required funding.

Stress prevention and individualized support is a vital intervention for students who are struggling.

That BCSTA urge the Minister of Education to review mental health support and increase collaboration between all provincial ministries that work with youth.

#### RATIONALE:

Students have identified mental health as a priority issue for them.

External and school stress has a direct impact on student achievement.

Although the province has programs in different ministries and departments, the services are not always coordinated or evenly available around the province.

#### 9. ADVISORY GROUP ON PROVINCIAL ASSESSMENT

**SUBMITTED BY:** *SD36 (Surrey)* 

#### **BE IT RESOLVED:**

That BCSTA urge the Ministry of Education to support the Advisory Group on Provincial Assessment's recommendations contained in the *Advisory Group on Provincial Assessment Final Report June 2014* by creating a standing Provincial Assessment Committee to continue the dialogue about assessment and the future of our provincial assessment program.

#### **RATIONALE:**

Surrey School District believes that our provincial assessment system needs to be significantly restructured. There has been a working group that has done significant work on assessment and we believe this important work needs to continue.

In 2013, the Ministry of Education invited representatives from a broad range of stakeholders to form an Advisory Group on Provincial Assessment (AGPA).

The group was asked to provide advice on five assessment factors concerning our provincial assessment program: purpose, design, content, stage of schooling and level of reporting.

In its report, AGPA made several recommendations including creating a standing Provincial Assessment Committee which would continue the dialogue about assessment and continue to foster collaborative relationships and understandings among stakeholders.

Our hope is that the strong work of AGPA would continue to inform the future of assessment in BC.

#### 10. BCSTA PROVINCIAL COUNCIL MEETINGS

**BE IT RESOLVED:** 

That BCSTA's Board of Directors reviews the February and October Provincial Council agenda preparation, time requirements and agenda topics with the intent of making the most efficient and effective use of the Saturday morning and afternoon Provincial Council sessions.

#### RATIONALE:

This motion addresses the importance of "careful stewardship" of BCSTA's resources. Provincial Council meetings held in October and February have generally begun informally on the Friday evening with a presentation and a reception followed by the official Provincial Council business meeting on Saturday. The Saturday business meeting agenda includes both a morning and afternoon session. However, the afternoon business session has only been needed on extremely rare occasions. The Saturday business meeting agenda traditionally includes presentation and adoption of oral and written reports, tracking of AGM resolutions and provincial council resolutions, any action items and emergent motions to Provincial Council. Past experience has been that these items have been dealt with in the morning session with adjournment of Provincial Council around noon. The Saturday afternoon session has not been used recently. The question has been raised of whether there is a way in which the unused time of the afternoon business session could be used to effectively enhance and provide meaningful involvement of the Provincial Council members. Bringing all 60 Provincial Council members together for a Friday presentation and reception and a morning session on Saturday is very costly to the Association.

# 11. CHANGES FOR A MORE USEFUL EARLY DEVELOPMENT INSTRUMENT

**SUBMITTED BY:** SD74 (Gold Trail)

#### **BE IT RESOLVED:**

That the BCSTA Board of Directors encourage the Offord Centre to work with the Human Early Learning Partnership (HELP, UBC) in consultation with the First Nations Education Steering Committee (FNESC) to make positive changes to the Early Development Instrument (EDI) both in the survey questions and in how the results are reported and shared with school districts.

#### RATIONALE:

Currently the EDI results do no more than to confirm the early learning / kindergarten-readiness challenges embedded in low socioeconomic districts while reaffirming that those districts in higher socioeconomic districts do not experience the same low EDI scores. The EDI results are used for political influence when they could be used to better inform practices. The EDI survey questions have not changed much since the survey was created, and although this may have some validity in consistency of tracking results, society, children, and our expectations have changed. In what has become best practice of play-based learning, we no longer expect our Kindergarten children to be proficient in the memorization skills of knowing their ABCs, counting and so on. Research has shown us that a focus on inquiry, play-based, and social and emotional learning best serves our early learners. Yet the survey questions still ask questions like "demonstrates special literacy / numeracy skills or talent". That not only leaves the teacher wide open to subjective evaluation, but may be asking the wrong question entirely.

Many Indigenous independent schools refuse to participate in the EDI survey due to the cultural bias inherent in the questions. This is an aspect that needs careful revision in collaboration with FNESC. This is obviously of concern to public school trustees as well, if we are to assess our students in a fair and equitable manner.

School districts will greatly benefit by receiving more detailed results of the EDI in order to better inform decisions and planning to address the needs of our early learners. It would be beneficial if HELP could provide templates, or coach districts in promising practices in making informed decisions with community-based intervention strategies.

- 3. makes recommendations to the Ministry and BCSTA on what can be improved in either the wording or implementation of the agreement going forward,
- 4. identifies progress made on subsidiary protocol agreements considered over the past year, and
- 5. identifies the subsidiary protocol agreements which are to be considered over the next year.

#### RATIONALE:

This motion is needed because BCSTA and the Ministry of Education have recently signed a co-governance agreement. The value of any agreement can be enhanced through ongoing monitoring of its effectiveness.

#### 15. FIRST NATIONS WELCOME

**SUBMITTED BY:** SD61 (Greater Victoria)

That BCSTA invite a local First Nations representative to conduct a traditional welcome on their traditional territory at all provincial BCSTA conferences and academies.

#### RATIONALE:

As the provincial organization representing school trustees, BCSTA has the responsibility to be a leader in showing respect for the people upon whose territories we live and do our work. Including local First Nations in provincial-level BCSTA meetings by inviting them to conduct a traditional welcome would be a clear demonstration of BCSTA's commitment to fostering respectful relationships with the 200+ Indian Bands in BC.

# 16. REPRESENTATION ON THE GOVERNMENT'S RURAL ADVISORY COMMITTEE

**SUBMITTED BY:** SD57 (Prince George)

#### **BE IT RESOLVED:**

That BCSTA urge the provincial government to include equitable representation from rural communities and Boards of Education throughout the province on the "Rural Advisory Committee" as proposed in the government's February 2015 Speech from the Throne.

#### RATIONALE:

The February 2015 speech from the throne stated "In the coming weeks, your government will introduce the 'Rural Advisory Committee', which will provide independent and impartial advice on helping rural B.C. increase opportunities, manage growth, and meet its full potential in communities big and small."

It will be critical that the "Rural Advisory Committee" has representation from those on the ground in rural communities where the need for increased opportunities and the management of growth are the challenges.

A process of collaborative inquiry where rural communities can learn from each other as well as from outside through "independent and impartial advice" is needed along with a commitment from government to provide the necessary investment and support to stimulate growth and potential opportunities.

Year after year, Boards of Education have brought the rural issue before government with little or no response to our advocacy. Throughout the province we have rural communities that continue to struggle to survive and rural communities that are experiencing unprecedented growth. In both situations these communities face significant challenges in providing the necessary infrastructure and supports, including "equitable access to quality public education for rural students in their communities." (BCSTA Policy Statement 5.1.2P Rural Education). BCSTA must continue to press the government to address the needs of rural communities and specifically to act on its commitment as stated in the February 2015 Throne Speech:

#### "RURAL COMMUNITIES

Your government will continue to work with rural communities across the province, increasing opportunities to build careers and raise families closer to home, meaning more growth in smaller centres.

As opportunities increase in smaller towns, your government is committed to help them meet the challenges that growth can sometimes bring.

In the coming weeks, your government will introduce the Rural Advisory Committee, which will provide independent and impartial advice on helping rural B.C. increase opportunities, manage growth, and meet its full potential in communities big and small."

# 18. REQUEST FOR SCHOOL BOARDS TO BE EXEMPT FROM CANADA'S ANTI-SPAM LEGISLATION (CASL)

**SUBMITTED BY:** SD44 (North Vancouver)

#### **BE IT RESOLVED:**

That BCSTA request that the federal government exempt public Boards of Education from Canada's Anti-Spam Legislation (CASL) to allow Boards to continue to share the diverse information parents and guardians need to fully support their child's school and learning experience, and that BCSTA take the motion to the Canadian School Boards Association to seek national endorsement.

#### RATIONALE:

On July 1, 2014, many provisions of Canada's new anti-spam legislation came into effect. This legislation includes restrictions on the sending of commercial electronic messages without the consent of the recipients. The federal government has established some exemptions to CASL, including exemptions for federal and provincial governments and registered charities.

This motion is important due to the profound difficulties Boards face to comply with Canada's Anti-Spam Legislation (CASL). The difficulty in separating non-commercial messages from messages that may refer, or link to, a fee-based program or cost-recovering educational activity is particularly problematic. Board of Education email content is designed to ensure that parents and guardians of students, as well as third parties engaged in business with the school district, are well-informed of initiatives and opportunities that may be available and of interest to them. Some, but not all such emails, will have a commercial component to their content (i.e., a cost-recovery fee for a field trip or program), and, as such, are considered to be "Commercial Electronic Messages" (CEMs).

Even with a significant investment in technology, staff time and training, (thereby reducing funding to teaching and learning) the broad scope of CASL's directives make it unworkable for Boards to fully and consistently comply with the legislation as it stands while maintaining a vital communications channel to parents.

That BCSTA request that the Ministry of Education, BCPSEA and support staff unions meet on a regular basis to review the last round of bargaining and make recommendations for change to the existing provincial collective bargaining process.

#### **RATIONALE:**

The parties at the last round of bargaining would benefit by meeting now while the experience is fresh. The best results for the next collective bargaining process will come from those who are responsible for enacting it. It is important the parties meet on a regular basis to create a process that builds respectful relationships and is beneficial for all.

# 21. EXPANDING THE LOAN FORGIVENESS PROGRAM TO ADDRESS STAFFING SHORTFALLS IN UNDER-SERVED AREAS OF BC

**SUBMITTED BY:** SD81 (Fort Nelson)

**BE IT RESOLVED:** 

That BCSTA actively urge the provincial government to expand the BC Loan Forgiveness Program to include all teachers and specialist instructors who relocate to under-served areas of BC.

#### RATIONALE:

Currently the loan forgiveness program is available to recent graduates of programs such as nursing, medical professions, midwifery and pharmacy programs, who are employed at a publicly-funded facility in an underserved BC community.

Within the educational domain, speech language pathology, occupational therapy, audiology and physiotherapy graduates, teachers for the deaf and hard of hearing, teachers for the visually impaired, school psychologists, and technology education teachers that are employed at a publicly-funded facility or school district in BC are also eligible for student loan forgiveness if they agree to work at publicly-funded facilities in British Columbia.

Those qualifying for the program will see the government of BC forgive outstanding BC Student Loan debt at a rate of 33 1/3 per cent of the total loans per year, and all related interest, discharging the BC Student Loan after three years of service.

The proposed expansion of the program would provide critical assistance to rural and remote districts currently experiencing a high level of difficulty in recruiting and retaining quality staff, in order to provide service to students.

#### 22. NEW TEACHER MENTORSHIP PROGRAM

**SUBMITTED BY:** *SD36 (Surrey)* 

**BE IT RESOLVED:** 

That BCSTA ask the Ministry of Education to: commit to providing ongoing funding for the New Teacher Mentorship Program (NTMP) to allow for the continuation and expansion of the program; and, share the findings of the NTMP research with Boards of Education across BC as this information will assist with the development of sustainable models of teacher mentorship across the province.

#### **RATIONALE:**

Surrey School District believes that quality teachers are the backbone of our education system. Research consistently confirms that the quality of the teacher is the main factor in student success and achievement.

Knowing the importance of teachers and their training, school districts across BC and the Ministry of Education continually invest in the quality of teacher training programs.

Since 2013, the Ministry of Education, the BCTF, UBC and the BCSSA have an established New Teacher Mentorship Program (NTMP) with the support of provincial grants.

We believe that effective teacher mentorship programs are a sound investment both in the short and long term and can benefit both rural and urban districts.

Funding for the NTMP is secured for two years ending in 2016.

Surrey School District believes this is a rich and important program and we welcome ongoing funding and support to benefit all districts.

#### 23. EDUCATION FINANCE

**SUBMITTED BY:** SD42 (Maple Ridge-Pitt Meadows)

#### **BE IT RESOLVED:**

That BCSTA

- a. work with all Boards of Education in the Province, the BC Association of School Business Officials, the BC School Superintendents Association and the Ministry of Education each year to establish the level of funding required to meet the needs of students attending public schools in British Columbia;
- b. make recommendations to the Province (through the Ministries of Finance and Education) on the level of funding and required revenues including taxation required to meet those needs;
- c. make recommendations on the funding formula and the budget process including the practice of holding back funding.

#### RATIONALE:

Many Boards of Education in BC have experienced significant funding shortfalls over several years resulting in substantial cuts to educational resources and programs.

The Provincial government wishes to achieve a balanced annual budget without increasing taxes.

The amount included in the annual provincial education budget is not based on the needs of the system identified by local Boards of Education but instead on an amount required to reduce costs necessary to balance the provincial budget without consideration for increasing tax revenues.

#### 24. CAPITAL FUNDING SUPPORT

**SUBMITTED BY:** *Kootenay Boundary Branch* 

#### **BE IT RESOLVED:**

That BCSTA urge the Ministers of Education and Finance to review the state of the schools and buildings in all school districts and request funding for Boards of Education to upgrade or replace existing buildings for the health and safety, and use of students and staff.

#### RATIONALE:

Annual Facility Grants are no longer adequate. Some Board of Education facilities are 60-70 years old. It takes many years for a request for capital funding to proceed through the Ministry of Education approval process for a new school or large capital upgrade project. In addition, every district is unique and has its own environmental challenges.

The purpose of the additional capital funding would be for repairing/replacing/upgrading school buildings, as was done with coastal schools for seismic upgrades. The health and safety of our students and staff are a top priority for all boards of education.

It is imperative that our schools be repaired or replaced to meet the ongoing needs of our students and their education.

# 25. FREE FERRY TRAVEL FOR STUDENTS WHEN TRAVELLING FOR SCHOOL BASED ACTIVITIES

**SUBMITTED BY:** South Coast Branch

#### **BE IT RESOLVED:**

That BCSTA urge the Ministry of Transportation to adopt a provincewide policy of free travel on BC Ferries for all BC students travelling for school functions.

#### RATIONALE:

This motion was brought forth by the South Coast Branch at AGM 2010. Since that time, there has been some movement by the Ministry of Transportation to rearrange the fee schedule on select routes to subsidize student travel. However, the revised fee schedule is not equitable to all school districts. For example, all SD46 (Sunshine Coast) students are able to travel free of charge for school events using a voucher system which has now been extended to all non-school sports teams (e.g. hockey and soccer teams that travel to the Lower Mainland for games). In contrast, SD47 (Powell River) students are still charged for travel to Vancouver Island, which is SD47's zone for BC School Sports.
