# Re: Proposal for Modular Classrooms at a Lake Cowichan Elementary School

The Cowichan Board of Education would like to thank you for the proposal made in your letter to the Lake Cowichan Town Council received by them November 2<sup>nd</sup> 2011. In this letter, you have offered to install modular classrooms at one of 2 school sites in the Lake community as an interim measure while the families and staff wait for their replacement for AB Greenwell School closed down due to mould since February 2008.

As you point out in the letter, this project has been the number one priority for the previous board in the most recent capital plan. Our new board has affirmed its commitment to the acquisition of a new elementary school at the Lake to replace AB Greenwell as our highest priority. We would like to thank you for your suggestion regarding the provision of modular classrooms. However, the community in Lake Cowichan has spoken loud and clear. They are not in favour of such a development. The families and employees as well as other concerned community members came together on January 16<sup>th</sup> 2012 to tell our board they do not believe this would benefit their children in the short or long term. In addition, they were very positive about the experience their kids are having in their current location at Yount School in Youbou.

Therefore, we must respectfully decline this offer. However, the Lake community wants their new school as soon as possible.

The schools at the Lake are in need of more care and upkeep than our dwindling budgets allow. Our Board in Cowichan therefore calls on the Minister to provide the funds which he would have allocated for the installation of modular classrooms to our district to permit us to proceed with much needed maintenance to the Lake Cowichan Schools.

Our recommendation, carried unanimously at the January 18<sup>th</sup>, 2012 Open Board meeting, is as follows:

"That the Board of Education SD #79 responds to the letter from Minister Abbott dated November 2, 2011 regarding a proposal to supply modular classrooms to the students of Lake Cowichan at either the Palsson School or AB Greenwell site in the following way:

First - While thanking the Minister, the Board wishes to decline the offer of modular classrooms.

Second - That the board calls on the Minister to provide the funds which he would have allocated for the installation of modular classrooms to our district to allow much needed maintenance to the Lake Cowichan schools.

Third - The Board of Education SD #79 affirms its commitment to the acquisition of a new elementary school at the Lake to replace AB Greenwell as their highest capital priority.

A letter to this effect will be written by the executive to be sent to the Minister and distributed to all school districts and all media."

Again, we thank you for this suggestion and we hope to see the best outcome for our kids at the Lake.

The families in that community deserve a new school and deserve excellent learning conditions while they wait. Our Board in Cowichan is prepared to stand with them in this endeavour.
