Re: Organization of Classes Report

Our Board in Cowichan passed a motion on January 4th 2012 rejecting the Organization of Classes Report offered by our senior staff for the month of November. This does not imply any criticism of our staff but certainly speaks to the board's deep dismay over the conditions which prevail in our classrooms.

We have been receiving the Organization of Classes Reports for many years. Trustees have always raised questions and concerns regarding the contraventions of Bill 33. As we do not believe these conditions are appropriate for student learning, this board has decided to take this step. Our board believes remaining silent signifies we are in agreement with the circumstances revealed by these reports.

In October 2011, we had 256 classes in our schools out of approximately 1200 classes which had class size and/or composition violations. In November 2011, 247 classes failed to meet the modest guidelines Bill 33 sets out. While the board is certain all the correct steps are followed and the paperwork is in order, this is hardly the point.

While the numbers on paper are discouraging, the reality in our classrooms is the true test. A test which is failed repeatedly while our employees struggle valiantly and our children miss out. Our educational leaders are expected to waste the precious time they might use for engaging with students and doing what they were so carefully trained to do in order to deliberate over bureaucratic procedures which bear no fruit and serve only to demoralize our families and our staff.

The board does not know the true cost of maintaining this oppressive record keeping but it seems likely whatever the cost may be, it would be better spent on resourcing our classrooms and nurturing our programs and services. After all, despite years of adhering to the processes demanded by Bill 33, we have seen no improvement in the conditions in our classrooms and it seems likely this will continue.

The Board of Education SD #79 invites the ministry to step up and resolve the many breaches of Bill 33 our district has outlined. A good start would be to provide funding which will allow us to staff our classrooms so our students can enjoy equal opportunities for learning in keeping with their needs and the commitment of our hardworking employees.

Lorie Firth, parent at Alexander Robinson Elementary, provided her comments on the direct impact of displaced siblings and further spoke to concerns by handing out a photograph of her children requesting consideration to prioritizing children.

Brent Green, parent resident in subdivision just past Jackson Hill, expressed concerns regarding his children being placed in Webster's Corners Elementary catchment for reasons including the travel distance in the opposite direction each day and had moved to the area prior to development and catchment review issues.

<u>Catchment Review – Eastern Schools Catchment Changes</u>

Acting Deputy Superintendent Meston referred to the report provided in the Agenda and acknowledged members of the public for the respectful and engaging comments and suggestions. The overall message received has been to keep siblings together.

The Board Chair thanked staff for the work conducted and parents for being helpful in providing feedback encouraging the public to continue with providing input.

Achievement Contract - Stewart Sonne, Director of Instruction, Secondary and Adult Education

Director Stewart provided an overview of secondary education including graduation rates, grade to grade transition and Aboriginal Education.

At a recent visit by the Superintendent of Achievement it was noted School District No. 42 is only one of two Districts that has had the greatest grad rate improvement and specifically commended the successes of the Aboriginal Education graduate students.

Director Sonne commended the passion of School District staff and teams who have conducted interventions based on data and followed up with all Aboriginal Education students. Staff have created strategies to help overall grad rates and commended Alan Miller, Principal, Aboriginal Education, and his team who have followed up with those students.

Due to Teachers' Job Action, George Serra, President, Maple Ridge Teachers' Association, was asked to congratulate the entire teaching staff on behalf of the School District.

In summary, Director Sonne promoted the caring for kids in the School District; understanding what a child knows; where they want to go; and encouragement to dig deep into that learning.

Discussion ensued regarding non-graduating students, stress levels of students with anxiety, depression and substance abuse.

Director Sonne reassured the Board students are not allowed to withdraw until they have followed due process and are matched with staff enabled to intervene and assist.

Chair Murray thanked Director Sonne and acknowledged the work of the School District's front line staff. It was suggested Director Sonne bring back staff from Student Support Services to provide a presentation.
