Dear Ministers De Jong and Fassbender:

RE: Exempt Staff Wage Freeze

On March 10th, the School District 5 (SD5) Southeast Kootenay Board of Education wrote to your Ministries voicing our concerns around the lack of exempt staff wage increases since 2009.

On March 23rd, 2015 Christina Zacharuk, Interim President and CEO of the BC Public School Employers' Association (BCPSEA) responded on your behalf, as per your request.

While we appreciate Ms. Zacharuk's timely response our Board takes exception with your Ministries' "passing the buck" to a civil servant on what is clearly a political issue.

As elected officials ourselves, Trustees are acutely aware that the money is the money. We are also aware that everyday we –and other politicians—make decisions as to where that money is spent. Our own Board has recently needed to make cuts in 33 areas of our budget in order to balance, while adding to a select few areas of our budget where greater need has been identified.

While school districts do not have a choice when it comes to how much income we receive, the provincial government does. It can choose to increase its revenue stream at any time in the form of income and consumption taxes (including taxes on the harvesting of natural resources), contributions to social security plans, the sale of goods and services and provincial investment income. To choose not to increase revenue streams is a political, not a fiscal choice.

While the decision to increase revenue streams vs. redefining budget priorities is not at issue for our Board, the inadequate funding of the BC school system (as outlined once again in the report recommendations of the 2015 Select Standing Committee on Finance and Government Services) and the need to restore education funding to a level that supports the basic needs of public education in BC is a serious issue for Boards across the province.

One of those basic funding needs pertains to the retention of quality staff with whom we rely to lead the K-12 education system. As mentioned in our previous letter, school district management and exempt staff have received zero wage increases since 2009 while their colleagues have deservedly received wage increases as per their most recent collective agreements.

The inequity of pay raises across the sector has created a level of compression that makes it even more difficult for districts such as our own to retain, promote or attract quality leaders. This is *our* fiscal reality.

To that end our Board carried the following motion at our June 9th, 2015 public meeting:

"That the Board of Education write a follow-up letter to the Ministers De Jong & Fassbender with a copy to the usual stakeholders, regarding the compensation freeze in management and exempt staff."

This increase <u>must happen</u> and it <u>must be fully funded by government</u> if Boards are to preserve the integrity and viability of pubic education going forward. Our kids deserve the best –not the least expensive— educational leaders.

Re: Follow up to June 3rd meeting

First let me thank you for meeting with the Board on June 3rd. We appreciate the opportunity to share our thoughts and situation with you so that you are well versed in advance of any discussion in caucus or with the Ministers of Education and Finance on the matters we reviewed. The intent of this letter is to follow up on our conversation.

Although we have copied several letters to your offices over the past year and have had a variety of informal discussions, the last formal meeting we held with you was on June 11th, 2014. We made several requests at that meeting and felt we should review our progress on those requests at our most recent discussion. The requests made in 2014 and our sense of progress or lack thereof since that time are listed below.

- 1. Acknowledgment from government that we are managing our resources very carefully and in a fiscally responsible manner. As noted in our discussion, the implementation of the surprise administrative savings requirement and follow up comments from members of cabinet suggest a lack of understanding of the work school boards are doing to manage their resources, as well as a lack of acknowledgment that we are making the difficult decisions required to balance our budgets. We take exception to the inferences made by government that Boards of Education have been inefficient. We believe a more direct dialogue is required between government and boards of education on the subject of education finance for government to fully appreciate the work boards do and have done to manage their resources effectively and to understand what is truly needed to properly support K-12 education. We have proposed a means to do that in the form of a resolution presented by this Board and passed at the 2015 BCSTA annual general meeting.
- 2. Acknowledgment from government that the cuts we are making now (and have made in the past several years) will have a negative impact on student success in the long term. As we mentioned during our most recent meeting, it is one thing to require cutbacks. It is quite another to do so and expect the same or better results despite the never-ending cycle of funding pressures being placed on school boards. We have given many examples of the impacts of these cuts on our operation in earlier correspondence and in the material we left with you. To suggest these will have no impact on student achievement is to seriously disrespect the work of the people whose positions have been eliminated from our system. Over the past year, there has been no such acknowledgment from government. We understand the need to reduce



service levels and outcomes to balance budgets. We simply wish an acknowledgment from government that the services we are cutting had meaning, were important to the people served, and that their elimination will have negative consequences.

- 3. A commitment to encourage other ministries to step up to meet their obligations to the children and families of this province. The story of Paige, which has been in the news so much of late, is an example we can relate to. As our Superintendent shared so eloquently at our meeting, there are a few Paige-like stories in every school district and we are very concerned. Certainly funding has a role to play in ensuring social service caseloads are at a level that an appropriate response can be achieved to this kind of situation. While they do try their best, the ministries we communicate with on a regular basis are challenged to meet the needs of our students in crisis and that is a huge concern. We continue our dialogue with those ministries to determine what can be done within the current resource levels to meet these very real needs, but know any significant progress will necessarily involve changes to the framework of support available in the province for youth.
- 4. A commitment to fully fund additional costs over which Boards of Education have no control (like labour contract settlements and pension plan increases) and cover other inflationary costs. While government representatives suggested they would do just this with respect to the teachers' settlement, they no sooner negotiated an agreement than they passed a provincial budget which included the administrative savings requirement offsetting a large portion of the cost of the settlement. On top of that, the Ministry of Education passed significant Next Generation Network costs along to Boards of Education (an additional annual cost of \$0.46 M for our school district). It is acknowledged that some inflationary costs have been addressed with increased per pupil funding, but this funding does not sufficiently address the shortfalls we continue to experience as a result of these requirements, BC Hydro increases and increased pension and MSP premiums, necessitating further service level cuts. The cuts to our district necessitated by these changes were outlined during our meeting and are identified in detail in the material we left with you. During the past two years we have made service level cuts of over \$8 M. The budget we just passed included additional service cuts of \$1.25 M over the next two years. These cuts involve eliminating busing and requiring students to provide their own devices (laptops, I pads, etc.).

In the recent past, we've increased class sizes, reduced student support and cut maintenance and administration as much as we dare. Principals and vice principals alone have been reduced by 15% leading to less attention being paid to students and less support for quality teaching. What we are now doing is passing additional costs along to parents. We said last year we would have to consider eliminating busing if government didn't provide sufficient funding and they didn't.



Government continues to indicate they are increasing the funding for education, and they are. Unfortunately the increases are insufficient to cover the increased costs negotiated by government and over which Boards of Education have no control. The chart we provided at our meeting (attached to this letter) demonstrates the actual per student level of funding has decreased since 2002.

- 5. A commitment to review and revise the current system of holding back funding. Some revisions were implemented and more money was released up front this year. Unfortunately the second half of the 2014 request was that government stop using portions of the holdback for purposes other than what it was originally intended for (to rationalize student enrollment adjustments). Unfortunately, government has chosen to use a portion of the holdback for the Next Generation Network, which will mean a smaller holdback amount available to districts who count on that money to balance their budgets. We are one of those districts.
- 6. A commitment to review and revise the current funding formula to ensure a fair distribution of resources across the province. Minister Fassbender committed to that review at the BCSTA AGM over a year ago and no discussion has occurred to that end.
- 7. A commitment to review and revise the current system of capital planning. Although we have not seen any proposals, we are assured by the Deputy Minister, Dave Byng, that changes are coming. We trust that will be the case and are pleased to have recently received approval on a capital project submission in support of our energy management plan, which will have a positive impact on our annual operating budget. We appreciate how quickly our request was dealt with following our submission of the relevant materials.
- 8. A commitment to review Government's tax policy with respect to school property taxes. We have subsequently recommended an overall review of taxation recognizing the need for balanced budgets going forward. As noted in our earlier letter, we believe government should have a courageous discussion with the public on this subject with a view toward generating the resources required to sustain the essential services citizens need, achieve the goals of the BC Education Plan and maintain a healthy economy. Government has continued to ignore any suggestion of increased taxation as a means to balance the provincial budget in an inflationary environment. School property taxes are still lower now than they were many years ago while the Municipal portion of property taxes have increased considerably. There is something wrong with this picture.

Unfortunately our review of last year's letter and subsequent actions by government do not indicate significant progress. In fact there is evidence of government doing just the opposite of what was requested without any dialogue on the need to do so. This has resulted in a great deal of frustration on the part of Trustees locally and throughout the province. The frustration being experienced has been exacerbated by the Minister's signing of a **co governance protocol agreement** last December with the BCSTA, which committed the parties to advance consultation on any significant policy change which



would impact the other party. This principle has been violated three times in relatively short order since the agreement was signed. The change in providing subsidized access to upgrading courses for adult graduated learners, the administrative savings requirement and Bill 11 were all surprises to Boards of Education. No pre-consultation was held on the first two and very little was provided on one portion of Bill 11. There was certainly no opportunity to review and comment upon the legislation before it was introduced to the house as has been the case with other legislation.

The sense of powerlessness being felt by Trustees is coupled with a significant current concern that our exempt personnel salaries have been frozen since 2009 while the rest of our staff compliment has achieved negotiated settlements. We congratulate government on achieving those settlements and are pleased with the length of term of those agreements. However, the exempt staff salary freeze is causing a morale problem among those we rely so heavily upon to provide leadership in our system. This is even more frustrating since management staff in core government service areas did receive a raise a year ago. Not only have our exempt staff not had a raise, they are under considerably greater pressure today than previously as a result of the budget cuts we have had to make over the past several years.

The freeze needs to be lifted and the required funding needs to be provided by the province to cover those increased costs. If the required funding isn't provided, we will be forced to find even more service level cuts in an already seriously stressed system.

In summary we hope you will:

- Encourage the Ministers of Education and Finance to participate more directly in an annual
 discussion of education finance with the BC School Trustees Association, BC Association of
 School Business Officials and BC School Superintendents Association to determine the amount
 of funding required to support the public education system we all want and need.
- 2. Encourage cabinet to provide the kind of support (financial and otherwise) necessary to respond appropriately to the needs of children in crisis.
- 3. Encourage the Minister of Education and the rest of government to honor the co-governance agreement with the BC School Trustees Association in all future endeavors involving significant policy changes. We would also encourage the Minister and Ministry Officials to make every effort to be present from start to finish at important meetings like the BCSTA annual general meeting. We believe the opportunity these meetings present for improved mutual understanding of the issues both government and boards of education are facing should not be missed.
- 4. Encourage the Ministries of Education and Finance to lift the exempt salary freeze and <u>fully</u> <u>fund</u> appropriate compensation increases.



In closing, we appreciate your willingness to meet with us directly so we can share our thoughts and concerns with you. We do hope the results of our discussions will be more fruitful than what we've experienced over the past year and look forward to that being the case.

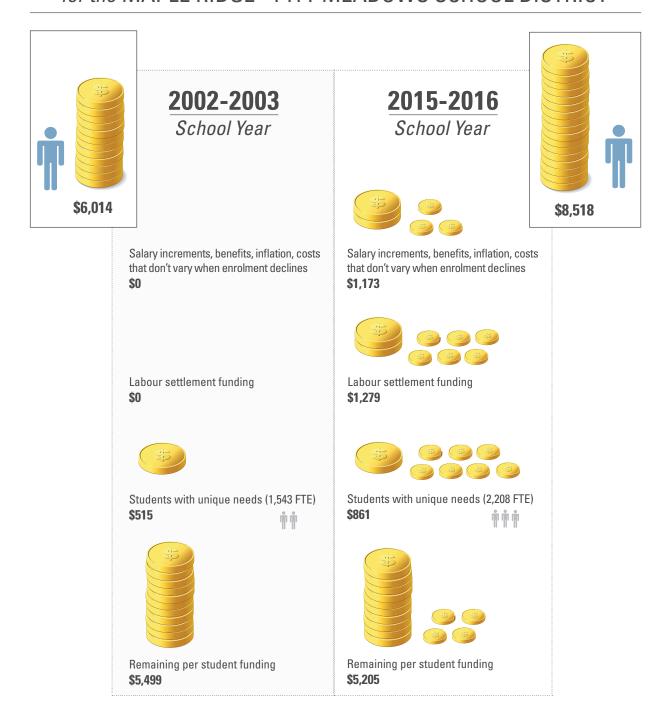

There was certainly no opportunity to review and comment upon the legislation before it was introduced to the house as has been the case with other legislation.

The sense of powerlessness being felt by Trustees is coupled with a significant current concern that our exempt personnel salaries have been frozen since 2009 while the rest of our staff compliment has achieved negotiated settlements. We congratulate government on achieving those settlements and are pleased with the length of term of those agreements. However, the exempt staff salary freeze is causing a morale problem among those we rely so heavily upon to provide leadership in our system. This is even more frustrating since management staff in core government service areas did receive a raise a year ago. Not only have our exempt staff not had a raise, they are under considerably greater pressure today than previously as a result of the budget cuts we have had to make over the past several years.

The freeze needs to be lifted and the required funding needs to be provided by the province to cover those increased costs. If the required funding isn't provided, we will be forced to find even more service level cuts in an already seriously stressed system.

In summary we hope you will:

- Encourage the Ministers of Education and Finance to participate more directly in an annual
 discussion of education finance with the BC School Trustees Association, BC Association of
 School Business Officials and BC School Superintendents Association to determine the amount
 of funding required to support the public education system we all want and need.
- 2. Encourage cabinet to provide the kind of support (financial and otherwise) necessary to respond appropriately to the needs of children in crisis.
- 3. Encourage the Minister of Education and the rest of government to honor the co-governance agreement with the BC School Trustees Association in all future endeavors involving significant policy changes. We would also encourage the Minister and Ministry Officials to make every effort to be present from start to finish at important meetings like the BCSTA annual general meeting. We believe the opportunity these meetings present for improved mutual understanding of the issues both government and boards of education are facing should not be missed.
- 4. Encourage the Ministries of Education and Finance to lift the exempt salary freeze and <u>fully</u> fund appropriate compensation increases.



In closing, we appreciate your willingness to meet with us directly so we can share our thoughts and concerns with you. We do hope the results of our discussions will be more fruitful than what we've experienced over the past year and look forward to that being the case.

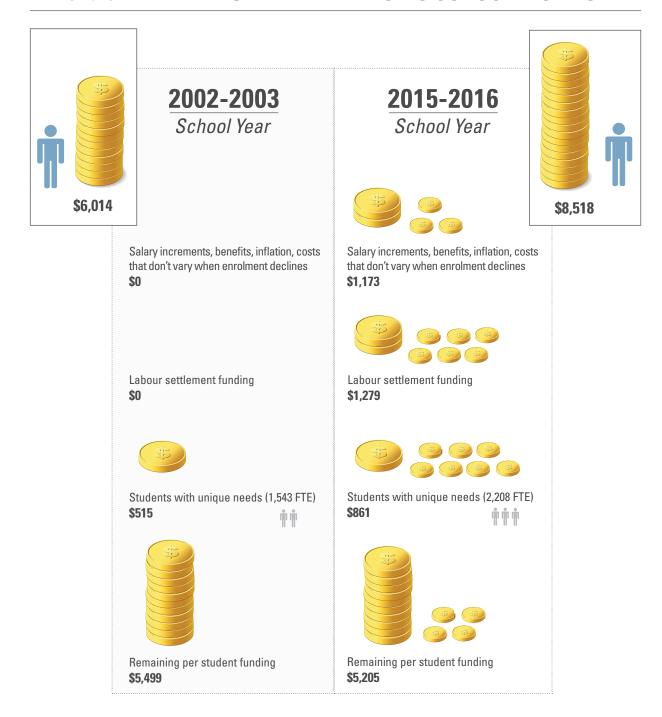

Re: Bill 11

In December 2014 you signed the Co-Governance Relationship Memorandum of Understanding with the British Columbia School Trustees Association. Our Board was in support of this agreement as we firmly believe than an effective co-governance relationship between Boards of Education and the Minister of Education is needed in order for the students of British Columbia to receive the education they deserve.

When Bill 11 was announced a few months later, without any notice to Boards or consultation with Boards, our Board was flabbergasted. The Memorandum of Understanding indicates that consultation and notification may be limited in extraordinary circumstances. When this occurs, an explanation for taking extraordinary action is to be provided. We are therefore asking for your explanation for proceeding with Bill 11 without consultation with, and without notification to, BCSTA and Boards of Education.

Of particular concern to our Board are the provisions of Bill 11 which provide you with the ability to issue administrative directives that would overrule the autonomy and authority of locally elected Boards of Education. In this regard, our Board stands behind the motions passed at the BCSTA AGM and forwarded to you by BCSTA.

Our Board also has questions with respect to the elimination of School Planning Councils. The implications for Parent Advisory Councils and the ability of parents to have input to school plans are unclear. We firmly believe that the advice and input of parents is essential for our schools to meet the needs of all learners, and so our Board is seeking clarity on how this process will work with the passing of Bill 11.

BACKGROUND/RATIONALE:

School District No. 42 is currently involved in a conversion from BCeSiS to MyEdBC student information system. Ongoing training will be happening with all employee groups throughout 2015-16 and includes secondary timetabling training that will be happening in the spring of 2016.

Teacher Training

There are three major training events that will be happening for teachers in the fall of 2015.

The first MyEdBC training event will occur in the afternoon of the first day of school on September 8, 2015. All staff will work with the principal to learn how to login to MyEdBC, set preferences and security settings. A refresher on the Freedom of Information and Protection of Privacy Act (FOIPPA) will also be completed.

The second MyEdBC training event will occur at the first staff meeting in September. All staff will work with the principal to learn how to take student attendance using the new student information system.

The third session involves teacher release time and covers MyEdBC system fundamentals. System fundamentals include filters, field sets, queries and reports. The MyEdBC team created the teacher training schedule initial draft. It was decided that the most efficient way to have training done for all teachers in a timely manner would be to run 3 daily sessions beginning Monday, September 14, 2015 through to Monday, October 22, 2015. There will be two 1.5 hour am sessions at the elementary schools that would cover the fundamentals training. The afternoon 2.5 hour pm session would be hosted at the secondary schools and cover fundamentals training and gradebook.

The proposed training plan was reviewed by the MyEdBC Steering Committee, the MRTA MyEdBC Committee and principals. Where possible, the feedback received was incorporated into the training plan.

Clerical and Administration Training Schedule

Many clerical training sessions have already been conducted over the last two months. All clerical training schedules have been designed with input from CUPE representatives, clerical staff and administration.

Information

BACKGROUND/RATIONALE:

The Information Technology Department is committed to providing the public and the Board of Education with timely updates to the district's technology plan. These updates provide a transparent mechanism to share information on major project milestones and the associated technology hardware and infrastructure expenditures.

Over the next six months the Technology Department will be very busy with the following ten major projects. All of these projects align to the published goals of the School District No. 42 IT Plan that was presented to the Board of Education in March 2015.

- 1. Implementation of the Next Generation Network (NGN).
 - The PLNet replacement network will be rolled out across the district in June and July. The last site update will occur on July 29, 2015. Much of the pre-work occurred in early May.
- 2. Wireless Internet Upgrades (Generation 4)
 - This on-going project will ensure that all classrooms have the wireless coverage and density necessary to delivery engaging learning opportunities for students.
- 3. Learning Commons
 - The IT Department has been working closely with secondary school librarians to ensure that their technology needs and other resources align with their learning commons goals.
- 4. MyEDBC Support
 - The IT Department is deeply involved in supporting the MyEdBC Student Information System implementation. IT staff will support the clerical and teaching staff as they transition from BCeSiS.
- 5. Hardware Replacement
 - Staff computers that are over 5 years old will be replaced in July and August (400 devices to be deployed).
- 6. District Email and SharePoint Upgrades
 - The district-wide email system will be fully updated by the end of June.
 - The SharePoint document warehouse will be upgraded by October 31, 2015.

- 7. International Education Parent Portal Module
 - This important addition to the parent portal will allow homestay parents to be notified of upcoming field trips and allow International Education staff to authorize these trips in the portal. This module will be completed by the end of October.
- 8. Upgrades to Secondary School Servers
 - All servers will be updated by the end of November.
- 9. Online teacher Collaboration Site
 - Planning work continues on the online teacher collaboration site.
 - The site will be online and available to teachers by January 2016.
- 10. Print Management / Reduction
 - Phase one has been completed and includes the installation of reporting and print auditing tools.
 - Phase two will be completed by October and will give schools more control over their print resources.
