## **RE: Current Labour Dispute**

As you will recall, it was at the will of government that, last June, the BC Public School Employers'Association (BCPSEA) Board of Directors –comprised of nine elected Trustees—was fired and Government appointed a public administrator to assume the responsibilities of BCPSEA and its Board.

Trustee representation is now reduced to two members, in an advisory capacity only. Representation by Boards of Education in the bargaining process has been rendered marginal and minimal.

It is with this added frustration therefore that our Board is writing to express its concern and dismay over the ongoing labour dispute and apparent stalemate at the bargaining table.

We wish to add our voice to the growing number of Boards across the province that are urging government to reach a fair, negotiated settlement prior to school start-up in September. We wish to reiterate the damage this situation has —and continues—to cost students, families, staff, communities and the integrity of public education itself.

Our Board urges government to bargain now and to bargain fairly; to go to the table with the true intent of making a deal, including the negotiation of class size and composition, as that right was awarded to the BCTF in the 2014 Judge Griffin ruling. Court decisions and Appeals only cost taxpayers money and injure relationships.

If agreement cannot be reached, we urge government to immediately seek mediation or if necessary, binding arbitration. Our Board doesn't see any long term benefit to a legislated resolution and anticipates considerable damage if agreement is not reached prior to school start-up in September.

We also urge government to fully fund any and all costs associated with bargaining and contract settlement.

Once again we remind government that education is not a cost to be managed but an investment to be made –in our children, our economy and our future.



It is with grave concern that we write of the impact on our school district and community with the current impasse in the labour dispute between the BCTF and the government. A negotiated settlement must be found immediately to ensure that our children's education begins on September 2<sup>nd</sup> as planned.

Whether the students are Kindergarten children entering school for the first time, or elementary and secondary students with critical goals ahead of them, they are being kept in a stressful state of insecurity and uncertainty. Our parents and children, teachers and support staff, trustees and administration, as well as our entire community, are profoundly affected by not knowing when or if the situation will be resolved.

We write to you therefore, urging you to please resume productive bargaining for the sake of our children's future. Our voices echo the concerns expressed by so many Boards of Education across the province, the BC School Trustees Association and the many anxious parents and caregivers waiting for a settlement to this dispute. We raise our voice to urge you to not impede the vision that BC's public education system can indeed be located in "the best place on earth". We implore you to act before more students leave



the public system for independent schools free of labour disruption.

We appreciate the efforts being made by all parties in this situation. For the sake of all people in BC, we trust that a fair settlement will be negotiated post haste and restore confidence in our leaders.

Thank you for your efforts thus far. Please do more.

The Board of Education of School District No. 20 (Kootenay-Columbia) is seriously concerned about the state of bargaining between the BC Teachers' Federation (BCTF) and the BC Public Schools Employers' Association (BCPSEA). After 18 months of bargaining we remain without a negotiated settlement and in the middle of a full scale withdrawal of services by teachers. We believe that the reputation and effectiveness of British Columbia's public education is being weakened through this protracted labour dispute. A negotiated collective agreement is critical if our public education system is to be able to move forward.

We support the BC School Trustees Association's letter of June 23, 2014 and call for the parties to act quickly to:

- 1. immediately re-convene ongoing face-to-face bargaining;
- 2. agree to the appointment of a mediator as soon as possible; and
- 3. mutually agree not to bargain through the media.

Further to our three previous letters this school-year alone, our Board continues to advocate for increased, stable funding for the public education system. We urge the Minister of Education to fulfill the commitment that any settlement be fully funded by the government.

Dear Premier Clark and Minister Fassbender:

The Board of Education of School District No. 20 (Kootenay-Columbia) joins with other Boards from across our province calling for a negotiated labour settlement to be achieved prior to September 2, 2014 so that classes can begin as scheduled. Our communities are anxious heading into the end of the summer not knowing if our students will have teachers in front of them for the first day of school. The lack of face-to-face bargaining over the first 6 weeks of the summer break was disheartening. We were excited to hear about the engagement of Mr. Ready to mediate but were dismayed to hear that the parties have not resumed bargaining even after his engagement.

The ongoing labour strife is damaging the public education system of British Columbia. As a Board we have advocated consistently to build and maintain the high quality public education system that our youth deserve. We have written the Minister numerous times sharing our concerns about the chronic underfunding of public education, the need for government to fully fund labour settlements and sharing our support for the BC School Trustees' Association's advocacy efforts. We support the BCSTA's recent *Back to School Action Plan*. The goal and objectives of the action plan are fully endorsed by our Board. Most importantly, we want our schools to be open on September 2<sup>nd</sup> with our full staff compliment having reached a fair and funded settlement.

Lastly, the recent announcement of using strike savings to pay parents of students under 13 years of age \$40 per day should the strike continue into September was shocking. Boards were not consulted about this plan which further undermines the co-governance model. We believe that these funds should remain in the public education system and be used to maintain and enhance service rather than short term financial relief for families. We appreciate that families are feeling the impact of the strike and lockout but the money should be used to meet the needs of vulnerable learners. As per the BCTSA *Back to School Action Plan*, those funds should be held for enhancing the Learning Improvement Fund.

We urge you to get personally involved in helping achieve a settlement in the ongoing labour dispute so that schools can open on September 2, 2014.

### Re: The Current Labour Dispute

The Central Okanagan Board of Education held a Special Public Board Meeting on August 6, 2014 to discuss the BCSTA's Back to School Action Plan and the meeting planned for August 8, 2014 between BCTF and BCPSEA.

The Board has endorsed the BCSTA's Back to School Action Plan, and in particular wishes to emphasize that any monies saved during the strike/lockout should remain within the public education system and not be used for any other purpose.

The Board is pleased that the August 8<sup>th</sup> meeting is occurring, and is hopeful that a resolution to the current impasse can be found so that schools will reopen, as scheduled, on September 2, 2014.

The Minister has said that the government is prepared to bring some additional concepts to the table, and the BCTF has indicated they will bring some new ideas forward. These statements leave us feeling more optimistic that a settlement will be reached. We urge the parties to reopen negotiations, bargain in good faith behind closed doors, and come to an agreement.

It is unthinkable that the strike/lockout situation will continue into September. Our students need to be back in school where they belong. We believe their parents value the education system and want their children in school to learn and grow, not just to be "baby-sat". On the other hand, parents do not need to be struggling to find child-care spaces in safe, licensed facilities. We know that these child-care places are almost impossible to find at the best of times, so the pressures that will be placed on families should the dispute continue past the end of August are unacceptable and we believe unnecessary.

Dear Premier Clark and Minister Fassbender:

The Board of Education of School District No. 27 (Cariboo-Chilcotin), at its meeting on 24 June 2014 passed the following motion:

"THAT the Board of Education write a letter to the Premier of BC and Minister of Education requesting that an external, independent review be completed on impacts of class size and composition.

The Board of Education, itself, has called on independent consultants in the past to provide an independent review of programs and district operations, such as alternate education programs and administrative requirements. Reviews are very beneficial and provide an updated viewpoint and insights on very important topics.

With the appearance of a stalemate between the BCTF's and the Government's negotiations surrounding class size and composition, perhaps it is time an independent external review be conducted. If both the BCTF and Government were to commission it, the results then could not be viewed as biased.

As the labour dispute drags on, optimism is waning, and we look to your government to resolve the dispute as quickly as possible. The students, parents and employees have borne the pressure of this conflict for the last decade. That means a student entering grade 10 this year has been exposed to a war zone of teachers' and support staffs' constant battles with government. This can only result in a negatively affected educational experience.

As leaders in this province, the Board urges you and your government to give serious consideration to resolving class size and composition issues and recommends an independent, external review of the topic.

Contract negotiations between the BC Teachers' Federation and the BC Public School Employers' Association are at a point where the well-being of students, staff and the education system itself are negatively affected. The school year has ended with the education labour dispute unresolved and an utter sense of disappointment in the contract negotiations system. This type of drawn out, unresolved dispute is a dis-service to public education staff, BC families, and especially the taxpayer.

For BCTF and BCPSEA to continue negotiations in the absence of a mediator does not seem effective or successful. We strongly urge the BCTF and BCPSEA to begin open, unfettered mediation and get on with the task expected of them – achieving contract resolution as soon as possible. Flexibility and full acknowledgement of the support needed in BC classrooms is expected of both negotiating parties.

Out of respect for the BC public education system, the BCTF and BCPSEA need to ensure the following actions are completed as soon as possible:

- Immediately return to effective negotiations with a mediator, and negotiate continuously until resolution is reached.
- Acknowledge a meaningful wage increase for teachers, fully funded by government.
- Create and negotiate a new compromise on class size and composition; one which is not bound by dated formulas, but rather a real commitment to classroom support.

We fully believe that the labour dispute urgently needs a mediated resolution, certainly well before the efforts of a new school year need to begin.

I am writing on behalf of the Board of Education of School District 38 (Richmond) to express our grave concern about the current labour dispute affecting public education and to request that you take whatever measures you can to ensure that the collective bargaining process resumes without any further delay.

Ongoing uncertainty going into the fall results in a multitude of problems – from staffing levels and decisions, to maintenance issues and budgeting for supplies. Our schools will also suffer from a hit to our reputation – both internationally in terms of the International Student Program where continued labour strife will certainly result in decreased enrollment in our programs, but locally as well, as parents reconsider the public school system and if it is best for their children.

The ongoing dispute is not only extremely damaging to public education in BC, but it also has the potential to have negative connotations for economic growth in the province. For example, the International Student Program (ISP) generates approximately \$10 million a year in revenues for School District 38. This is a program that has been grown and developed over the years, and which competes with similar programs across Canada and around the world. Across the province, ISP revenues are an important contributor to the provincial economy, and the short and long term repercussions of an ongoing labour dispute will be significantly felt. In addition, many small businesses have been impacted by the labour dispute. Daycares are an example of a small business segment that has been directly impacted by the labour dispute, since many of them operate in school facilities (as encouraged by Provincial Government policy). These small businesses have already had to close because they could not access school facilities during the strike, and if the dispute were to extend into September they would again be forced to close their doors to the children they care for. When these economic concerns are added to the more readily apparent educational ones, the cost to the entire province of BC of a prolonged labour dispute is tremendous.

We respectfully request a meeting with you to discuss this important issue.


Dear Minister Fassbender,

At a recent meeting, the Board of Education for the Coquitlam School District decided to write you to express our deep concern with the state of funding for public education, and specifically highlight the funding shortfalls which exist within the context of our School District.

All children have a right to an education system which is responsive to their needs – not just the children who are easy to educate. Our school district has become a leader in improving graduation rates, an objective which was clearly articulated as a priority by our Board of Education and by the Ministry of Education. In this school district, we have found ways to address the needs of many more children who are at risk of failure. That said, we are not complacent about the fact that some children in our system still have far less chance of reaching graduation than others. As inflation continues to outpace any incremental funding to the school system, we are continually faced with having to cut educational programing to absorb cost pressures. All school districts require adequate and stable funding which allows them to reach all students.

To illustrate this point, since the 2009/10 fiscal year, the Coquitlam School District has seen its per student funding change from \$6,880 to a projected \$6,966 in 2014/15. Had the per student funding amount in 2009/10 kept up with inflation, per student funding in 2014/15 would have been \$7,492 per student. This \$526 difference per student is significant. Considering our student base, it demonstrates that we have had to absorb \$16.3 million in cost pressures over the past 5 years. It is our position that these monies be returned to the school district.

## Rates of Funding and Inflation - 2009/10 to 2014/15 - Coquitlam School District

School District 43 was able to reduce its operating budget by \$13.4 million to ensure a balanced budget for the 2014/15 fiscal year. That said, the impacts to the public education system are tremendous. In order to balance the budget, the District\*\*:

- Eliminated 91 teaching positions including Psychologists, Speech Language Pathologists, High Incidence Teachers, Librarians, Student Services Coordinators, Counsellors, and Teachers working to maintain class size and composition
- Eliminated 55 support staff positions, including many Noon Hour Supervisors and Maintenance positions
- Eliminated 33.5 educational support positions which includes Teaching Assistants, Youth Workers, and Library clerks
- Eliminated 2 Administrator positions despite opening a new middle school
- Closed middle school cafeterias
- Eliminated before and after school busing for students

During our public budget meetings, it was clear that these cuts would impact all students, especially those students who are most vulnerable and most in need. The Board of Education empathized with the many parents and guardians, teachers, administrators and support staff, who spoke with emotion about the reductions that the Board of Education had to implement. We are greatly saddened that the cuts we were forced to make will limit our ability to help students achieve their full potential as individuals and citizens.

The Coquitlam School District has had a history of student success. The impact of these cuts will be devastating and our continued high-level of achievement is in jeopardy. While the dedicated professionals in our District will continue to go above and beyond, there are limits to what can be accomplished with such reduced resources.

The Board is greatly concerned by the potential of further inflationary costs and new cost pressures. The 2014/15 budget assumed that any provincially negotiated labour agreements with CUPE and the BCTF would be fully funded. Further, it is assumed that any negotiations to settle issues around class size and composition would also be fully funded.

Minister, we ask that you fully consider the impact that lack of adequate funding is having on our system. Further, we ask that you work to restore our funding by:

- Increasing our 2014/15 allocation to reflect inflation over the past 5 years
- Building into future funding a provision for inflation
- Ensuring that any labour agreements are fully funded
- Ensuring that any settlement regarding class size and composition is fully funded
- Committing to reviewing funding for vulnerable students to ensure that their needs are met
- Committing to reviewing the funding formula to ensure equitable funding amongst all School Districts

We are writing regarding the possibility that schools may not open on September 2<sup>nd</sup> due to the ongoing labour dispute and the implications for our International Education Program. We are concerned that labour instability in the Province of BC in the short-term will have long-term negative repercussions on the success of our efforts internationally. If schools do not open in September, international students may decide to withdraw from our programs and attend school in other provinces or countries. The potential financial loss to our Board and our communities is staggering.

- As a Province, we appear to be taking international students, their tuition fees, and their passion for our public education system "for granted" and not valuing their contribution. International education is a \$2 billion industry that is crucial to the economy of the Province of BC.
- Our international revenues contribute provincially to employment, the housing market, retail sales, private academies, and tourism. International students become new Canadians and attract immigration and new business opportunities to our Province.
- As a school district, international education brings significant additional revenues to our operating budget providing us with the flexibility to meet the needs of students and contributing to student success.
- The International Education Program has in turn helped to build the economies of our local communities of Coquitlam, Port Coquitlam, Port Moody, Anmore, and Belcarra as well as the Province of BC.
- The lack of a strike resolution by September 2nd may result in the inability in the K-12 sector to fulfill its commitments to international students.

- The apparent lack of concern for international education during the current labour dispute contradicts the concept and spirit of Board revenue generation.
- Our Board of Education has embraced the Liberal government's initiatives as outlined in <u>British Columbia's International Education Strategy</u> document, published in 2012 as part of the BC Jobs Plan to encourage Boards of Education to generate revenue and become more entrepreneurial.
- In the report by the BC Progress Board, established by the BC Liberal government in July 2001,
   <u>The Role of International Education: Expanding Student Opportunity and Economic
   </u>
   <u>Development in British Columbia,</u> recommendation 4 says that the government must: "Support the international education sector's role in regional economic development."
- According to a recent report of the Council of Ministers of Education (<u>Education ministers signal transformation key to the future</u>, July 9, 2014): "International education continues to be a high priority for ministers. They reaffirmed the importance of Canada's position as a preferred study destination for international students and agreed that they would continue to work with the federal government to strengthen Canada as a brand, which is already being used by institutions across the country as part of their international marketing strategies."
- Entire nations have seen their international programs fail as a result of carelessness and lack of stewardship. It may not be possible to rebuild.

As a Province, we must think globally and act locally. The Board of Education of School District No. 43 (Coquitlam) exhorts both of the parties to reach an expeditious, negotiated agreement or mediated settlement through continuous bargaining throughout the summer in order to preserve the BC Brand and our position at the forefront of the global education industry.

I am writing to you on behalf of the Board of Education of School District 43 (Coquitlam) to urge you both to use the influence of your respective offices to facilitate and encourage the BC Teachers' Federation (BCTF) and the BC Public School Employers' Association (BCPSEA) to urgently continue their bargaining efforts, with the full support of the mediation expertise of Vince Ready.

Further, we would like to share our grave disappointment with the Government's recent announcement to remove strike savings from public education. Like many other Boards of Education, we learned of the proposed \$40/ day childcare subsidy through the media. As co-governors of public education, an announcement of this nature should never come to Boards of Education as a surprise. When this happens it seriously undermines the trust required to work collaboratively to benefit the students of British Columbia. Further, it produces additional and completely unnecessary acrimony in the education sector.

The public perception of the chaos surrounding public education shifts focus away from the many strengths of our public education system.

Our Board strongly supports the BC School Trustees Association (BCSTA) Back to School Action Plan proposal that states that all strike savings be returned to the Learning Improvement Fund (LIF).

We are sensitive to the financial hardship parents will experience as a direct result of the delayed start to the school year. The proposed \$40/ day subsidy will bring some financial relief to parents. With a shortage of regulated and affordable childcare spaces available in the Lower Mainland, however, we are concerned that unregulated "pop-up" childcare options may represent a safety concern for some children, particularly our most vulnerable.

We are in the eleventh hour but believe that a final opportunity to resolve the current impasse remains with the mediation support of Vince Ready. We are looking to all parties involved in teacher collective bargaining to focus on finding an immediate resolution that will benefit students, parents and teachers and ensure a September 2nd start to school.

#### RE: An open letter to the community from the North Vancouver Board of Education

The impacts of the labour dispute between the British Columbia Public School Employers' Association (BCPSEA) and the British Columbia Teachers' Federation (BCTF) have been widely felt in our community, where high standards of education are the prevailing norm.

As Trustees, we have heard from many students, parents and employees about the effects that the current job action has had upon their learning and their lives. We do understand the many frustrations that have arisen from the dispute and we are concerned for all our students, parents, teachers, support staff, and administrators if the current situation should continue into September.

We have also been asked about our role in the dispute and what we have done, as a Board, toward a positive resolution. As an employer, the Board of Education is represented by BCPSEA and there are two Trustees representing the views of BCSTA at the provincial bargaining table. Our provincial body, the BC School Trustees Association, developed a <u>Back to School Action plan</u> through provincial-wide Board feedback with the goal of having the school year begin on time on September 2<sup>nd</sup>.

We have been consistent in our message to all concerned that we want to see a negotiated or mediated settlement as soon as possible that provides long term stability for students. The West Vancouver Board of Education would like to express its profound displeasure with your government's unilateral announcement to pay \$40/day to parents of children 13 years and under this fall, should the BCTF labour dispute continue beyond the summer.

We have worked hard to establish and maintain a respectful discourse with the government and build strong relationships with the many stakeholders in BC public education, despite ongoing cost and political pressures. The current impasse continues to have an enormous impact on the fine reputation of BC's education system, and we have shared our concerns on several occasions with BC's Minister of Education, Peter Fassbender.

The announcement to redirect strike savings to parents rather than direct them into the Learning Improvement Fund as prescribed in the BCSTA's Back to School Action Plan dismisses this Board's concerns, along with those of hundreds of thousands of BC parents and students. We are clearly in troubled times for education in British Columbia. Like many school districts across the province, School District No. 46 has written you several times asking for a commitment to reach a freely negotiated collective agreement with teachers. Yesterday's announcement of a \$40/day program for parents is an appalling step in the wrong direction.

We are dismayed that, like your Ministry's announcement on July 31, 2013 that the BCPSEA Board of Directors would be replaced with your own appointed administrator, the announcement timing of a parent subsidy on July 31, 2014 prior to a long weekend appears to justify the opinions of many that you are not interested in supporting a healthy relationship with all partners in education.

To take funds that all citizens contribute to public education and use them to continue a game of "gotcha" with the BCTF is misguided at best. Parents already express concern about the tax implications, administrative costs and how this subsidy will likely never reach those who need it most. There is no surplus of daycare spaces available in BC at any price. To single out students 13 and under also reductively emphasizes the custodial aspect of our system when families throughout the province are clearly more upset and alarmed about their children not receiving their fundamental right to public education. This is another hasty, ill-conceived decision.

It is not too late to change direction. We urge you to:

- rescind the offer of \$40/per day and keep the funds in education where they will benefit all students:
- ensure your negotiator has the resources at the table to negotiate in the interests of public education in British Columbia;
- keep bargaining out of the media until an agreement is reached; and
- bring some flexibility to enable a mediator to assist the parties to find an agreement.

It is our sincere hope that some of the commitment and pride that your government brings to the goal of a balanced budget can be brought to the goal of a functional, world-class education system. Please change your course and put the students of British Columbia first. It is they who suffer the longer you fail to negotiate but who can succeed beyond our expectations if we all determine to work together.

The Powell River Board of Education would like to express its shock and disappointment at the news which we received yesterday.

Like other school districts in the Province, we pride ourselves on offering quality educational opportunities for our young people, even in the face of on-going financial challenges. Over the years of conflict between the BCTF and the Provincial Government, we have seen increasing stress placed on our students, parents, staff and community. This year has been particularly difficult with year end activities curtailed and a failure to complete proper examinations, report cards and forward records of students wishing to enter post-secondary institutions. In addition, summer programmes have had to be cancelled and now we are having to tell our incoming international students that they will probably not be able to register for the fall semester.



The Powell River Board of Education met today to discuss the ongoing labour dispute and the likelihood that our students will not be able to return to school next week.

Like other districts in the Province, School District #47 prides itself on a history of offering quality learning opportunities for our students and, as trustees, we are concerned that not only are these opportunities being jeopardized by a failure to reach a negotiated settlement with the teachers' union but moreover, the continuation of conflict is likely to have a negative effect upon relationships within our classrooms, our schools and our community for some time to come.

Over the past several months, we, like many other boards, have written letters to members of your government as well as to the President of the British Columbia Teachers' Federation, expressing our concerns and urging both parties to engage sincerely in the process of bargaining - a process that should be taking place at the bargaining table rather than through the media.

We believe that the decision to take public tax dollars that are intended to support public schools and redirect them to pay for daycare is both an inappropriate use of tax dollars as well as an insult to the public education system which, despite on-going funding challenges, provides high quality learning opportunities for our young people.

Further, we believe that creating and promoting a parent information website a week prior to the scheduled beginning of a new school year indicates that the government is making clear to teachers and to the public that it is not prepared to move forward to resolve the on-going dispute.

As strong advocates for children and for public education, we strongly urge your government to demonstrate a willingness to move toward a resolution of the conflict, and to support public education, financially and ideologically.



I am writing on behalf of the Board of Education to convey its concerns about the current dispute between the Province and the BCTF. This is an appeal to both parties to show reason, generosity and forbearance in the conduct of negotiations.

The mere fact of a dispute such as this is damaging, but the damage can be either mitigated or exaggerated depending on the pace and the means by which the dispute is conducted. For instance, the provision of misleading, incomplete, ambiguous or ill-timed information by either party may serve to advance short-term interests, but it does immeasurable damage to the humans who are at the focus of the dispute. Serious harm is done due to both the slow pace, and the conduct during bargaining. This damage to relationships on the ground in our district has an enduring effect that counters any gains being sought. In this dispute teachers, support staff, management staff, parents, students, and our communities are truly hurting.

The public's confidence in public education is also significantly diminished as a result of such bargaining strategies, and this is another serious concern.

Our plea, therefore, is for a quick resolution to this dispute. We believe the best possibility for such a resolution is to be found with a suspension of both strike and lockout, an immediate return to the bargaining table, and a



Re: Views on Bargaining

The Board of Education of School District No. 52 (Prince Rupert) held a special meeting last night to discuss the current state of bargaining between BCPSEA and BCTF. The many letters that other districts have sent on this topic were considered. In our discussion we focused on why we ran to be trustees – to do the very best for the students in our district. Over the last 5 years this Board has made some very difficult decisions, including school closures and a grade reconfiguration. These decisions are not easily made when your position as trustee is framed within a local election cycle; but we focused on what would be best for our students over the long term.

In the current dispute between BCPSEA and BCTF, we believe both parties also need to focus on students and focus on the long term. We strongly believe that stability in the system is essential in order for districts to provide effective programs for students. That stability will not be achieved if this round of bargaining does not result in a full and final settlement of the court cases arising from Bills 27 and 28.

We believe this settlement is essential – and we also understand it is not easy to achieve. As with the resolution of Bill 29 in the health care sector, the government needs to bring money to the table, outside of the bargaining mandate, and both parties need to be realistic in order to agree on an appropriate amount and on the way in which the funding will be used.

With respect to addressing class size and composition in the collective agreement, we concur with the Quesnel School District that a "new compromise" is needed. Our district has significant numbers of vulnerable students, so we know first-hand the challenges of meeting the needs of each student in a classroom based on the principle of inclusion. Local boards and local teachers' unions need the flexibility to address local conditions, so we believe funding should not be formula-based, but situation-based. We encourage BCPSEA and BCTF to focus on the needs of students and work together to arrive at this "new compromise."

We also reiterate what many other districts have already said: don't bargain in the media; legislation is not the solution; and the final agreement must be fully funded by the government.

It is our sincere hope that the parties will return to the bargaining table in the near future, continue to bargain in good faith, and conclude a long-term agreement that will begin a new era of labour peace in the BC public education sector.

I write today on behalf of the Board of Education of School District No. 61 (Greater Victoria). Our Board is quite taken aback by your government's unilateral announcement regarding the repurposing of education dollars to provide \$40.00 per day for child care in the event that the current labour dispute extends into the 2014-2015 school year.

The Ministry of Education, the Ministry of Finance and your government as a whole appears to have completely lost focus on the issues at hand, firstly supporting public education, and, secondly negotiating a collective agreement with the British Columbia Teachers' Federation (BCTF). Our Board has repeatedly called on your government to properly fund and resource public education. We along with other Boards and the British Columbia School Trustees' Association (BCSTA) have urged your government to focus on finding solutions to this bargaining impasse. We have called for mediation, and a renewed focus on finding a solution. We believe that there is a common purpose that is shared by the Ministry of Education and the BCTF—the recognition of the value of public education for our youth in British Columbia.

This announcement does damage to an already damaged relationship between the parties, it undermines public education and further it signals to parents and students that the government is planning for continuing uncertainty and confusion in the K-12 public education system. Your energy would be far better spent in finding a solution to this impasse.

It is ironic that on the very day that your government makes this announcement you received the BCSTA "Back to School Action Plan". Your government's actions, taken without consultation and with a seemingly complete disregard for co-governance will not lead to certainty. We urge your government to support the BCSTA "Back to School Action Plan".

We are less than a month away from the school year start-up. We now have a circumstance where everyone involved in the K-12 system in BC is unsure as to when the school year will begin. Minister our concern is for our students—they do not get a "do over" and there is no second chance for them to fully regain what will be lost.

Minister, we are very concerned that both parties are working at brinkmanship when both parties need to be advocating for public education and our students. Now is the time to be focussing on solutions and keeping education dollars in Education, for the benefit of our students, parents, teachers and public education itself.

The Okanagan Skaha Board of Education is writing this letter on behalf of our education community which includes teachers, support staff, administrators, parents and students to express our shock at your announcement that money saved by the government due to the ongoing labour dispute would be paid to parents of students under 13 years of age at an amount of \$40 per day should the strike continue into September.

This Board of Education strongly feels that monies dedicated to education through governmental budgeting should remain in the education system whether the funds are the result of strike savings or simply regular annual funding. It is our position that long-term stability and sustainable funding is a high priority of our advocacy and to see these funds removed rather than being reiterated back in to the budget is disappointing. These funds could easily have been used to extend or enhance the Learning Improvement Fund (LIF) directly affecting our most vulnerable learners and meeting one of the suggestions in the BC School Trustees Association Back to School Action Plan (www.bcsta.org).

We acknowledge and appreciate that families are feeling the impact of this ongoing dispute and that the financial alleviation of some of this impact would be appreciated or deserved; however, we must question the source of this funding as our public education system is already struggling with underfunding on an ongoing basis.

We continue to advocate for a negotiated settlement between these parties before September 2<sup>nd</sup> and strongly urge your ministry's advocacy of the same.

The Board of Education of School District 68 (Nanaimo-Ladysmith) was stunned when the Board of Directors was fired and Government appointed a public administrator to assume the responsibilities of BCPSEA and its Board of Directors in June 2013. Despite holding strong reservations about this turn of events, the Board was initially appeased by government's assurance that this was, "an interim measure until such time as the necessary legislation is in place to restructure the bargaining process," and that in the interim, as co-governors of the system, Boards of Education would, "remain in an advisory capacity to government and BCSTA as they work to redefine BCPSEA's role for the future."

At that time Teresa, you stated that, "Now, more than ever, BCSTA must work with member Boards of Education to ensure that our interests are fully included in the new bargaining structure. This news represents a significant change in the collective bargaining landscape for public education. I am reassured to see that the former BCPSEA Board members will continue to be involved in an advisory role during the interim period. I am committed to including the tremendous knowledge and experience of these nine trustees as we develop new structures within BCSTA to ensure a strengthened voice for trustees in the bargaining process."

Our expectation was that, as the employer accountable for the process and outcome, Boards of Education would continue to have strong, meaningful representation at the bargaining table. However, no legislation has been forthcoming and the Board is disappointed to observe that, with government taking the lead on bargaining provincial matters, trustee representation was reduced to two, in an advisory capacity, and the role of Boards of Education in the bargaining process has been rendered marginal, at best. This is a flawed and unsatisfactory arrangement and therefore, this Board is respectfully requesting that the trustee representatives be withdrawn from the bargaining table forthwith, while hoping that the parties can conclude an agreement without further disruption to the system.

I write on the behalf of the Board of Education of School District 68 (Nanaimo-Ladysmith), in response to the announced proposal by Finance Minister de Jong that the savings from the strike/lockout be used to provide funds to parents for daycare or tutoring assistance if a settlement is not reached prior to school opening on September 2.

While we recognize that a prolonged strike creates financial hardship and inconvenience for many families, the Board is troubled that the government would see this proposal by Finance Minister de Jong as a realistic and appropriate response. The offer of an allowance of \$40 a day to parents is an impractical strategy given that suitable licensed daycare and / or quality alternative tutoring are in woefully short supply. We also note that neither of these would adequately compensate for the loss of learning that would otherwise be taking place in our public schools.

This scheme will create blatant and deplorable inequities. In addition to the unreliable, universal availability of quality, alternative services for those who would qualify for the subsidy, secondary students who comprise approximately one third of our total student body are completely excluded.

The Board believes that any savings from the strike/lock-out should go back into the public education system to be used to the benefit of all students. We therefore urge the government to abandon this plan and, instead, invest the savings into the public education system as a whole.

The Board continues to believe that the appropriate solution to this problem is a negotiated agreement or mediated settlement to be achieved by continuous bargaining through the summer, thus allowing schools to open on time.



#### **RE:** The Current Labour Dispute in BC Schools

The Board of Education in School District No. 71 (Comox Valley) joins our fellow Trustees and Boards of Education in declaring our serious concern with the current state of the labour dispute which has created so much upheaval in BC's public school system. The school year has ended without an outcome that would allow everyone to move forward in a positive anticipation of next school year. Students, families, staff and our communities are increasingly anxious about how our system can continue to thrive and support learners when year after year we find ourselves in protracted labour relation battles. The current situation is undermining confidence in public education and we are concerned as morale is at an all-time low and anxiety levels are at an all-time high.

To move ahead it is clear that both parties must continue bargaining through the summer months, earnestly and sincerely, towards a resolution that:

I write on behalf of the Board of Education, Kamloops/Thompson School District No. 73 to ask that you use the influence of your office to encourage parties bargaining on behalf of the BCTF and BCPSEA to continue in their efforts, both public and private, to arrive at a collective agreement prior to the end of August.

Further, we ask that you reconsider last week's proposal, announced by Finance Minister de Jong, to use savings realized as a result of teacher job action to assist parents of children under the age of thirteen with daycare costs should the dispute extend into September.

The Kamloops/Thompson Board of Trustees endorses the BCSTA's Back to School Action Plan which proposes any savings be directed back into the Learning Improvement Fund where they can benefit all students. On behalf of the Board of the Education for Coast Mountains School District 82, I write to you today to express our overwhelming displeasure with the government's proposal that the savings realized as a result of teacher job action will be used to assist parents of children under the age of thirteen with daycare costs or tutoring assistance if a settlement is not reached prior to school opening on September 2.

While we are not insensitive to the financial hardships facing families who must secure quality care for their school-aged children should schools not open in September, we strongly believe the monies should be retained in the education system where they can be directed to meet the needs of all students.

The Coast Mountains Board of Education endorses the BCSTA's *Back to School Action Plan* which proposes any savings be directed back into the Learning Improvement Fund where they can benefit all students as intended. #### Dear Premier:

I am sending this note to express my opposition to the provincial government's current funding policy and strategy with respect to public education.

As a parent, I have observed the impact of reduced effective funding in the Maple Ridge/Pitt Meadows school district. I understand that while the actual number of dollars invested into the education system may have increased, the buying power of those dollars has decreased. My specific observations include:

- 1. My daughter was unable to perform lab experiments in her high school biology class as there were insufficient supplies as well as an insufficient number of workstations for all classroom students to participate.
- 2. There were an insufficient number of textbooks in my daughter's grade 11 social studies class (a required course). As a result, students resorted to photographing textbook pages in order to complete their studies.
- 3. In an effort to accommodate increased costs, the local school district has increased the cost to community service organizations for the use of school premises. As a result, Scouts and Girl Guides groups, who have historically used school facilities for their meetings, have been forced to find other accommodations. I fully understand that the success of volunteer/non public education programs are not the direct responsibility of the school district or the provincial government, however I am absolutely convinced that these types of programs are critical to the development of our future society.

The recent action of the provincial government with respect to the teacher job action appears to underscore a lack of respect for the teaching profession and there appear to be some significant inconsistencies in government policy.

- 1. During previous job action, teaching was identified as an "essential service" and classroom operations resumed during the dispute. In May of 2014, this designation was not pursued and schools closed. In June, following completion of the regular school year, LRB decisions determined that year-round schools were "essential". It is not clear to me why a subset of the public education system is essential while the majority is not. At this time, no declaration/determination has been made identifying any part of public education as "essential" and, of course, all public education is stalled.
- 2. The action of the government with respect to the \$40.00 / day rebate to parents of young students appears to equate teaching with "day care" and appears contrary to statements that education is an important part of provincial services. Without stipulations about how the \$40 / day rebate is to be spent, it is not at all clear to me that these funds (which are directly associated with taxes collected under the umbrella of public education) will provide education benefit to young children. Older children, those aged 13-18 who are arguably those most impacted by the current situation, have not been extended any form of relief.

I believe that the current course of action will have long term impact to the effectiveness of the BC public education system. At a minimum, this impact will include:

- 1. A marked reduction in volunteer efforts of teaching staff who feel disrespected in the current negotiation process. Obviously, teachers will return to work once negotiations have been completed, however goodwill has been lost and may never be re-established. As you are aware, teachers have historically committed significant personal money and time into making the classroom environment as inviting and productive as possible. Without these very tangible contributions, classroom provisioning will be left dependent on district funding which is stretched beyond reasonable limits. The end result will be a severely degraded learning environment for our children.
- 2. A significant decline in new teachers entering the profession. To qualify as a teacher in this province, an individual must complete a minimum of 5 years of university. As university costs have increased, this is no small financial investment. Historically, once a teacher is qualified, it takes a number of years of part time work in the profession before a permanent position is obtained. There are many career choices and the chronic underfunding of education will dissuade many from pursuing the 5-10 year commitment required to obtain permanent employment.

I urge this government to significantly increase funding and support of all aspects of public education.

# Look Beyond the Numbers in Ongoing Education Dispute: An open letter from BCSTA President Teresa Rezansoff

With September 2 just around the corner, the bargaining impasse between the provincial government and the BC Teachers' Federation hinges on numbers – numbers about wages, benefits and class size. But behind those numbers are over half a million students who are waiting anxiously to start their school year on time. Whether it is their very first day in kindergarten or the beginning of their last year as a high school student, they are the reason any of those other numbers matter. School trustees across BC want our schools open and ready for students on September 2.

We have called on the government to immediately put strike savings back into schools to help address concerns regarding class size and composition. We have told the Ministers of Education and Finance that the money for the proposed \$40-a-day subsidy for parents would be better spent on students in schools. We continue our advocacy for improved education funding, and our trustee representatives at the bargaining table are calling for maintaining flexibility on class size and composition to improve the learning settings for students.

The two parties are approximately a percentage point apart on salary and one year apart on the proposed term of the contract – items that could be resolved through mediation. However, the proposed increases to benefits, the workload fund and the \$5000 signing bonus request makes the full package well outside the affordability range. BC's public education system ranks among the very best in the world, due in large part to our talented and dedicated teachers. Trustees believe that teachers deserve a fair wage increase, but the BCTF's overall compensation proposal needs to be aligned with other BC public sector agreements.

The issues are complex. This is not just about money. Ultimately, we need an agreement that meets the needs of students and provides long-term stability for public education. A deal can be reached. Students can be back in school on September 2. The government and the BCTF must move on the numbers and put students first.

# Back to School Action Plan

# Goal

The goal of the *Back to School Action Plan* is to have all BC public school students start their 2014-2015 school year on time.

# **Objectives**

- 1. A negotiated agreement with the BC Teachers' Federation by August 31, 2014.
- 2. Teachers, support staff and administrators in schools to welcome students and parents on September 2, 2014.
- 3. Schools sites are clean, safe and equipped to receive students by September 2.
- 4. Harmonious relationships are restored with teachers, support staff and administrators.
- 5. A commitment by all education partners and government to work collaboratively to strengthen BC's public education system.

# **Background**

Boards of Education are deeply concerned about the impact of the ongoing bargaining impasse on students, families, staff, and the reputation of BC's public education system. In many districts, summer programs for BC and international students have been cancelled or constrained. Parents are growing increasingly worried about the uncertainty of school start-up in September. Summer maintenance and repairs in many schools have been hampered. The lives of our teachers, support staff and administrators have been significantly impacted, and most critically, our students may lose their chance to start the school year on time.

BC school trustees are fully aware of the complexities of the current bargaining impasse. As the governors of BC's local school districts and employers of staff who make our schools successful, BC school trustees know that a balance must be found between the bargaining objectives of the BC Teachers' Federation and the economic mandate established by the provincial government. We believe that such a balance can be found.

We urge teachers to modify the increases they are seeking including their benefit requests so that the overall compensation package falls within the range that was accepted by other public sector unions. We ask government to put all of the savings from the strike and lockout into the

Learning Improvement Fund (LIF) to support students, student learning, and class size and composition. We believe that our students have been the most affected by the strike/lockout and would benefit from the enhancement to the Learning Improvement Fund where local decisions can be made to support their learning needs. These two recommendations could bring a negotiated settlement within reach that would then allow schools to open on time.

There is much work to be done to ensure that the world class achievement of BC's public education system is sustained and strengthened in the years to come. With our students and the long-term prosperity of our future citizens in mind, we must commit to working together to build a strong public education system that is student-centered, collegial and appropriately funded. We are committed to have our schools open on September 2.

# Actions

- 1. BCSTA's trustee representatives at the bargaining table will work towards a negotiated settlement that falls within the economic mandate set by the provincial government and makes improvements to class size and composition.
- 2. BCSTA will advocate that all savings resulting from the strike and lockout stay within the public school system to benefit students.
- 3. BCSTA will ensure that member Boards of Education are kept informed through increased conference calls with BCPSEA, the BCSTA Bargaining Advisory Committee, the Bargaining Representative Council, and Board Chairs.
- 4. BCSTA will work with BCCPAC to keep parents informed.
- 5. BCSTA will work with the First Nations Education Steering Committee (FNESC) to ensure that funding for Aboriginal students is not negatively affected due to the strike/lockout.
- 6. BCSTA will advance this action plan by advocacy to government and raising public awareness through general and social media.
- 7. BCSTA will establish a productive co-governance relationship with the Ministry of Education.
- 8. BCSTA will work with all education partners to establish a new bargaining and labour relations structure as per the recommendations identified in BCSTA's October 2013 Bargaining Structure Task Force Report.

Re: Use of teacher strike savings

Dear Premier Clark and Minister Fassbender,

I am writing on behalf of the Board of Education for School District No. 42 (Maple Ridge - Pitt Meadows) in response to the latest announcement by government to use the funds saved from the salaries of striking teachers to pay parents of students under 13 years of age \$40 per day should the strike continue in September. While we appreciate the financial hardship a continuation of the strike/lock out will impose on British Columbian families we cannot endorse the government's plan.

The BC School Trustees' Association has tabled an action plan to end the current impasse suggesting the use of these funds to enhance the learning improvement fund. The BC School Trustees' Association proposal was tabled as a suggestion to end the impasse by September. We sincerely hope that is achieved. However, if a settlement is not reached by then we still believe the funds should be retained for use to achieve a final settlement in the fashion described by the BC School Trustees' Association. We understand the government plan provides a short term benefit in the form of financial relief for families. In our view taking that step removes an important tool from the bargaining team to end this impasse and achieve a longer term benefit for students in the form of increased learning improvement funding. For the sake of our students and a stronger public education system please reconsider the strategy which has been announced and adopt that suggested by the BC School Trustees' Association.



Please know we are also very concerned that the government plan was developed without any consultation with the BC School Trustees' Association or Boards of Education despite our co-governance role. This kind of unilateral decision making is not helpful at a time when we have been working to improve the co-governance relationship. We all know working more closely together will be extremely important if we are to achieve the goals we share for education in this Province.

Re: An open letter to the community from the Maple Ridge / Pitt Meadows Board of Education

We want our students and teachers back in school. We are extremely disappointed and angry that the BCTF and BCPSEA have been unable to reach an agreement in the current labour dispute. The theatrics, vitriol, game playing, personal attacks and politics that have characterized this and previous rounds of bargaining between teachers and the provincial government are, quite simply, unprofessional and unacceptable.

We have heard from many students, parents and employees who are directly affected by the current job action. We understand and share their frustrations, and believe a continuation of the dispute will have a significant long-term negative impact on the public education system in this province.

Over the summer, the BC School Trustees Association developed and promoted a <u>Back to School Action Plan http://www.bcsta.org/publications/media-releases</u> through province-wide feedback from Trustees. We endorsed that plan but neither the government nor the BCTF have given it any consideration.

Since there is apparently no end in sight, we now call upon the parties to enter into binding arbitration on all of the issues on the table, including wages and benefits, as well as class size and composition funding and the method of allocating such funding. The only preconditions we feel should be set by the parties are that the result be fair to both sides: affordable for citizens and appropriate for teachers, demonstrating the level of respect for the teaching profession our teachers deserve. We also believe the provincial government must commit to providing full funding to Boards of Education to cover the results of binding arbitration. Finally, we want our students and teachers to return to school while the arbitration process takes place.

We have a great deal to be proud of in the provision of education in Maple Ridge – Pitt Meadows School District.
